

Grand Junction, Colorado
April 30, 1918

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present:
Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

The minutes of the regular meeting of April 23d were read and approved.

The quarterly report of the Commissioner of Highways was submitted and read, and on motion of Commissioner Vedder, seconded by Commissioner Vorbeck, the same was referred to the auditor.

The following bills having been examined and approved by the Commissioner of Public Affairs and audited, were read by the Clerk:

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows:

All the Commissioners having voted yea, the motion was declared carried and the bills allowed.

The contract with L. C. Akin for the use and cultivation of Palmer Park was presented and read.

Moved by Commissioner Vedder, seconded by Commissioner Blackstone, that the contract with L. C. Akin for the use and cultivation of Palmer Park be accepted and that the Mayor and Clerk be authorized to sign the same on behalf of the City.

The motion being put, upon call of roll, the Commissioners voted as follows:

All the Commissioners having voted yea, the motion was declared carried.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, C. H. Latimer desires to connect with the sewer in Sewer District No. 3 the following described real estate, to-wit: Lots 9 and 10, Block 20,

Milldale subdivision, City of Grand Junction, and

WHEREAS, \$35.00 is a fair and just price to be paid for the said connection; therefore, be it

RESOLVED, that the said property may be connected to said sewer on receipt of said sum of money, which money shall be credited to Sewer District No. 3.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, Geo. Hardenberg and J. A. McLuen desire to connect with Sewer District No. 3 to the houses on the respective real estate owned by them as follows: (Hardenberg tract)

and (J. A. McLuen tract)

and

WHEREAS, \$35.00 is a fair and just price to be paid by each of the said parties for the said connections; therefore be it

RESOLVED, that each of the said parties may connect to the said sewer their respective houses on receipt of said money, which shall be credited to Sewer District No. 3; and be it further

RESOLVED, that connections are for only the respective houses now constructed and that no further houses shall be connected under this permit or other connections made.

Moved by Commissioner Blackstone, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council adjourned.
