

Grand Junction, Colorado
May 28, 1918

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present:
Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of May 21st were read and approved.

A proposed ordinance, entitled "An Ordinance Concerning the Water Rates or Rents and the Collection thereof, and Amending Section 1 of Ordinance No. 206, passed and adopted November 3, 1912," was introduced and read.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows:

All the Commissioners having voted yea, the motion was declared carried and the proposed ordinance passed for publication.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the proposed ordinance passed for publication.
