

Grand Junction, Colorado
July 19, 1918

Pursuant to adjournment, the City Council of the City of Grand Junction convened at four o'clock p. m., in the City Hall, with Commissioner Vedder, acting Mayor, in the chair.

Upon call of roll, the following Commissioners responded as present: Vedder, Blackstone, Holmburg. Absent: Commissioners Cherrington and Vorbeck.

The minutes of the regular meeting of July 9th and special meeting of July 11 were read and approved.

The quarterly report of the Commissioner of Water and Sewers was submitted and read, and on motion of Commissioner Blackstone, seconded by Commissioner Holmburg, the report was referred to the auditor.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Council appropriate out of the General Fund the sum of \$75.00 to the Food Conservation Committee of the Woman's County Council of Defense for the establishment of a community canning kitchen for the months of August and September.

The motion being put, upon call of roll, the Commissioners voted as follows:
Vedder, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

On motion of Commissioner Blackstone, seconded by Commissioner Holmburg, the Council adjourned.
