Grand Junction, Colorado August 29, 1918

A communication from the Sinclair Refining Company, in reference to the location of an oil distributing plant in this city, was read.

The following resolution was thereupon introduced and read:

RESOLUTION.

WHEREAS, the Sinclair Refining Company of Denver, Colorado, desires to locate an oil distributing plant in this city; therefore, be it

RESOLVED, that the City Council of the City of Grand Junction welcomes the Sinclair Refining Company as business people to do business in this city, and be it further

RESOLVED, that the said Sinclair Refining Company be granted permission to locate their oil plant and tanks on the location chosen south of Sixth street, on land of the Denver & Rio Grande Railroad Company; provided, that in using same plant and location they comply with the ordinances and regulations of the City of Grand Junction.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

The following quarterly reports having been examined and approved by the auditor and the Commissioner of Finance and Supplies, it was moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the same be accepted and ordered placed on file:

The motion carried.

The bid of Ashley & Oats being found to be the lowest, it was moved by Commissioner Vorbeck, seconded by Commissioner Vedder, that the bid of Ashley & Oates for tinting the rooms of the City Hall, in the amount of \$102.00, be accepted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

On motion of Commissioner Holmburg, seconded by Commissioner Vedder, the Council adjourned.
