

Grand Junction, Colorado
October 4, 1918

The City Council of the City of Grand Junction convened in regular adjourned session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present:
Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

The minutes of the regular meeting of September 24th and adjourned session of September 25th were read and approved.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, the hereinafter described property was sold for delinquent taxes, the tax sale certificates being numbered 20,096 and 20,097, the said property being described as follows: East one-half of lots 19 and 20 and all of lot 18, Block 116, in the city of Grand Junction, Mesa county, Colorado, and

WHEREAS, in the opinion of the City Council it is desirable to make a settlement with the mortgagee of the property; be it

RESOLVED, that the Commissioner of Finance and Supplies be and hereby is authorized to sell said tax sale certificates for their face value, plus 6 per cent interest from date of sale.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows:
Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

The report of the City Weigher for the month of August having been examined and approved by the Mayor, the same was on motion of Commissioner Holmburg, seconded by Commissioner Vedder, accepted and ordered placed on file.

The report of the City Weigher for the month of September was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Vedder, the same was referred to the Mayor.

Mayor Cherrington recommended the purchase of 1500 feet of White King fire hose from the Good rich Rubber Company.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be instructed to purchase for the use of the Fire Department 1500 feet of White King fire hose from the Good rich Rubber Company.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Holmburg, seconded by Commissioner Vedder, that Tuesday, October 15, be designated as the day for the submission of department estimates for the next fiscal year to the Commissioner of Finance and Supplies.

The motion carried.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council adjourned.
