

Grand Junction, Colorado
November 6, 1918

All the Commissioners having been duly notified, the City Council of the City of Grand Junction convened in special session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Holmburg. Absent: Commissioner Vedder.

The minutes of the regular meeting of October 29th, adjourned meeting of October 31, and special meeting of November 2d were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the same was referred to the Mayor.

A report of the testing of the City scales was read.

A communication from F. C. Moys, Mayor of the city of Boulder, in reference to the Influenza situation in that city was read.
