

Grand Junction, Colorado  
December 3, 1918

The City Council of the City of Grand Junction convened at four o'clock p. m., in the City Hall.

The Mayor being absent, the Clerk called the meeting to order, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, Commissioner Vorbeck was elected President pro tem.

Upon call of roll, the following Commissioners responded as present: Vorbeck, Blackstone, Holmburg. Absent: Commissioners Cherrington and Vedder.

City Attorney Tupper was present.

The minutes of the regular meeting of November 26 were read and approved.

Rev. E. G. Lane appeared before the Council and asked for financial assistance from the City to carry on the work of the "Flue" office of the Civilian Service of the Red Cross.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the report was referred to the Mayor.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Council appropriate \$150.00 for carrying on the work of the Civilian Service of the Red Cross, \$50.00 of which shall be paid out of the General Fund and \$100 out of the Police Fund.

The motion being put, upon call of roll, the Commissioners voted as follows: Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.
