

Grand Junction, Colorado
December 31, 1918

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present:
Cherrington, Vorbeck, Blackstone, Garber, Holmburg.

The minutes of the regular meeting of December 24th were read and approved.

Revs. Lane and Thibadeau appeared before the Council in reference to the work of the of the civilians' "Flue" office, making report of the work done and money expended by said office during the epidemic of influenza, and made appeal for financial assistance form the city in order to continue the work of the office for another month.

The Council took no action in the matter, but the Commissioners agreed to render financial assistance for a continuance of the work, provided the Commissioners of Mesa County did likewise.

J. W. Rader having made application for a renewal of his license as master plumber and his bond having been examined and approved by the City Attorney, it was moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the bond be accepted and placed on file and the license granted.

The motion carried.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be instructed to place \$500 insurance on the dwelling house in Lincoln Park.

The motion being put, upon call of roll, the Commissioners voted as follows:
Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, Arie Huyser on February 13, 1918, paid \$10.35 to the County Treasurer for special assessment on Lot 25, Block 96, City of Grand Junction, which was credited to Paving District No. 5, the said money having since been paid to the City Treasurer, and

WHEREAS, the said payment was a mistake on the part of the County Treasurer, there being no such special assessment on said lot; therefore, be it

RESOLVED, that a warrant be drawn to Arie Huyser for \$10.35, the said amount to be charged to Paving District No. 5.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the Daily News be designated as the official newspaper of the City from and after January 1st, 1919.

The motion being put, upon call of roll, the Commissioners voted as follows:

Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Vorbeck, seconded by Commissioner Garber, that the City pay Danny Sullivan, 232 South avenue, \$13.00, for expense incurred in bailing water out of cellar, it appearing on investigation that the damage was partly due to negligence of the City, and that this payment be a settlement in full for all claims.

The motion being put, upon call of roll, the Commissioners voted as follows:
Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

On motion of Commissioner Vorbeck, seconded by Commissioner Garber, the Council adjourned until Thursday, January 2, 1919, at four o'clock p. m.
