

Grand Junction, Colorado, March 4, 1919.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Garber, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of February 25th were read and approved.

The report of the City Weigher for the month of January having been examined and approved by the Mayor, the same was on motion of Commissioner Holmburg, seconded by Commissioner Garber, accepted and ordered placed on file.

The report of the City Weigher for the month of February was submitted and read. On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the report was referred to the Mayor.

J. E. McKenzie having applied for renewal of license as master plumber and his bond having been examined and approved by the City Attorney, it was moved by Commissioner Holmburg, seconded by Commissioner Garber, that the license be granted and the bond accepted and filed.

The motion carried.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the Commissioner of Health and Civic Beauty be authorized and instructed to purchase for the City from Mrs. Yates a piece of land lying south of Riverside Park for addition to the park, and that a warrant for \$25.00 be ordered issued in payment of same, the

balance of the purchase price (\$25.00) having been donated by residents of the West Side.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The following resolution was introduced and read:

#### RESOLUTION.

WHEREAS, many complaints have come to members of the City Council that the electric lights in the city, both on streets and in buildings, are dim, and

WHEREAS, it appears to the City Council that the complaints are well grounded; therefore, be it

RESOLVED, that the manager of the Electric company furnishing electric current in the city be requested to appear before the City Council at the next meeting of the City Council. on March 11, 1919, and explain the reason for the poor lights and to show when the same will be remedied.

Moved by Commissioner Blackstone, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

A proposed ordinance, entitled "An Ordinance Providing for an Emergency Appropriation for the Sewer Department for the Enlargement of Outlets of Sewer Districts Numbers One and Two," was introduced and read.

Moved by Commissioner Holmburg, seconded by Commissioner Garber, that the ordinance as read be passed as an emergency ordinance, and that it be numbered 277 and ordered published in the official newspaper of the city.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the ordinance passed and adopted as an emergency ordinance and numbered 277.

A proposed ordinance, entitled "An Ordinance Concerning Salaries," was introduced and read.

Moved by Commissioner Vorbeck, seconded by Commissioner Garber, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the proposed ordinance passed for publication.

A proposed ordinance, entitled "An Ordinance Concerning the Inspection of Weights and Measures," was introduced and read.

Moved by Commissioner Blackstone, seconded by Commissioner Garber, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the proposed ordinance passed for publication.

All the Commissioners having voted yea, the motion was declared carried.
