

Grand Junction, Colorado, April 29, 1919.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Garber, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of April 22 were read and approved.

Mr. Herron appeared before the Council and asked for permission to tap the Kannah Creek pipe line for himself and other ranchers on Purdy Mesa.

Moved by Commissioner Garber, seconded by Commissioner Blackstone, that R. T. Anderson, Charles L. Miller, William Turnohan, Edward Berlin, and John Herrin be permitted to tap the Kannah Creek pipe line and that they be furnished water for domestic use.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Joe Leff having applied for a license to carry on the business of a junk dealer, it was moved by Commissioner Vorbeck, seconded by Commissioner Garber, that the license be granted upon the approval and acceptance of his bond.

The motion carried.

The following bills having been examined and approved by heads of departments and audited, were read by the Clerk:

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bills allowed.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, C. C. Whipple is the owner of the S 1-2 of N. W. 1-4 N. E. 1-4 S. W. 1-4, Sec. 13, T. 1 S., R. 1 W., and desires to connect the house thereon with the sewer in District No. 3; therefore, be it

RESOLVED, that the said Whipple be authorized and permitted to connect the said house to the sewer in District No. 3, on the payment of

\$40.00 in cash; provided, however, that the said payment shall permit a connection with the one house only.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the Council appropriate \$21.00 out of the General Fund for the publication of advertisements of the Victory Loan drive.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Blackstone, seconded by Commissioner Garber, that the Commissioner of Health and Civic Beauty be authorized and instructed to offer one cent per pound for dandelion roots brought to the city Fire House on or before May 31st, 1919, and that a prize of \$5.00 be given to the boy or girl under 15 years of age bringing the largest number of pounds of such roots, and a prize of \$2.50 for the second largest number of pounds and a prize of \$1.00 for the third largest number of pounds of such roots on or before said date; such roots to be dug within the city limits and to be free from dirt.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the water line in Lincoln Park be extended by the Water Department so as to make water convenient for the horse stables therein, and that the race track in the park be repaired by the Highways department.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

On motion of Commissioner Blackstone, seconded by Commissioner Garber, the Council adjourned.
