Grand Junction, Colorado, May 6, 1919.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Garber, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of April 29th were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the same was referred to the Mayor.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, the vault or privy upon the premises known as 336 North Spruce Street in Grand Junction, Colorado is not connected with the sewer of said City, and

WHEREAS, the Public Health of the community requires that the said vault or privy be connected with the sewer.

THEREFORE, BE IT RESOLVED that the owner of said property or his agent be notified to connect the same with the said sewer within fifteen days after receiving notice to so connect.

Moved by Commissioner Holmburg, seconded by Commissioner Garber, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber; yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the following resolution be passed and adopted:

RESOLUTION.

WHEREAS, the U. S. Department of Agriculture has determined that the destructive fungus commonly known as "black" or "stem rust" on wheat must pass one stage of its existence on the common barberry (Berberis vugaris), and therefore strongly urges the destruction of this shrub in all grain growing States, and whereas, the State Council of Defense has requested its destruction in Colorado; therefore, be it

RESOLVED, that the Commissioner of Health and Civic Beauty be and hereby is authorized and instructed to remove and destroy all the common barberry (Berberis vulgaris) now growing in the parks of the City of Grand Junction, on or before May 15, 1919.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

A proposed ordinance entitled, "An Ordinance Requiring a Permit for Erecting, Remodeling, and Altering a Building in the City of Grand Junction, and also Requiring a Permit for Moving any Building along the Public Streets of the City of Grand Junction," was introduced and read.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea; the motion was declared carried and the proposed ordinance passed for publication.

A communication from Frank R. Hall, in reference to stagnant pool of water in the gulch between First and Second streets near Teller avenue, was presented and read.

On motion of Commissioner Vorbeck, seconded by Commissioner Garber, the communication was referred to Commissioners Blackstone and Holmburg and the City Attorney.

A petion from C. F. Thomas and others in reference to objectionable refuse at the city dump and asking the opening of Belford avenue for traffic between First and Third streets, was presented and read.

On motion of Commissioner Vorbeck, seconded by Commissioner Garber, the petition was referred to Commissioners Blackstone and Holmburg and City Attorney Tupper.

The following bills having been examined and approved by heads of departments and audited, were read by the Clerk:

The bonds of J. S. Hynes, Fire Chief and City Weigher, and Joe Leff, junk dealer, having been examined and approved by the City Attorney, the same were on motion of Commissioner Holmburg, seconded by Commissioner Garber, accepted and ordered placed on file.

Moved by Commissioner Vorbeck, seconded by Commissioner Garber, that the following resolution be passed and adopted:

Resolution.

Whereas, Mr. Lee Strangers is the owner of lot described as follows:

"Beginning 63-3/5 ft. south of the intersection of west line of 5th. St. with the north line of the S.E. 1/4 of the N.W. 1/4 of Sec. 23 Twp. one south range I-W, thence west 145 ft., thence south 30 ft. thence east 145 ft. thence north to place of beginning." and desires to connect the house thereon with the sewer in Sewer Disct. #3; therefore, be it

Resolved, that the said Lee Strangers be authorized and permitted to connect the said house to the sewer in Sewer Disct. #3 on the payment of \$24.00 in cash; provided however, that the said payment shall permit a connection with the one house only.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.
