

Grand Junction, Colorado, June 17, 1919.

The City Council of the City of Grand Junction convened in regular session at four o'clock p.m., in the City Hall, with Commissioner Garber, acting Mayor, in the chair.

Upon call of roll the following Commissioners responded as present: Vorbeck, Blackstone, Garber, Holmburg. Absent: Commissioner Cherrington.

City Attorney Tupper was present.

The minutes of the regular meeting of June 10th were read and approved.

A communication from the Mayor was received and read, recommending the early passage of an ordinance increasing the salaries of policemen and firemen; the examination of all toilets in the city by the Commissioner of Water and Sewers, and the closing of the city offices at noon every Saturday during the months of June, July and August.

Communications from the cities of Boulder, Greeley, Fort Collins, Leadville and Loveland, stating the amount of salaries paid policemen and firemen of those cities, were read.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried and the bills allowed.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the Currie Canning Factory be notified by the Commissioner of Water and Sewers to install a water meter at its factory, in accordance with the provisions of Ordinance No. 255.

The motion carried by a unanimous vote of the Commissioners present.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the City Attorney be instructed to draw up an ordinance

prohibiting the use of city water for sprinkling lawns and gardens between the hours of 9 a. m. and 5 p. m.; provided, this regulation of the use of water shall not apply to the city parks.

The motion carried by a unanimous vote of the Commissioners present.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that during the months of June, July and August the city offices be closed every Saturday at 12 o'clock noon.

The motion carried.

On motion of Commissioner Blackstone, seconded by Commissioner Holmburg, the Council adjourned.
