

Grand Junction, Colorado, July 1, 1919.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Blackstone, Garber, Holmburg. Absent: Commissioner Vorbeck.

City Attorney Tupper was present.

The minutes of the regular meeting of June 24th were read and approved.

A proposed ordinance, entitled "An Ordinance Concerning Salaries," was introduced and read.

Moved by Commissioner Cherrington, seconded by Commissioner Garber, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried and the proposed ordinance passed for publication.

Moved by Commissioner Holmburg, seconded by Commissioner Garber, that a committee of two be appointed to make arrangements for band concerts in the city parks, with power to act in the matter.

The motion carried by a unanimous vote of the Commissioners present, and the Mayor appointed Commissioners Blackstone and Holmburg to act as said committee.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the telephones in the offices of the Commissioner of Highways, Commissioner of Water and Sewers, and the Commissioner of Health and Civic Beauty be ordered discontinued.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

Moved by Commissioner Garber, seconded by Commissioner Holmburg, that the Commissioner of Finance and Supplies be authorized to sell the old Thomas auto truck for not less than \$100.00.

The motion carried by a unanimous vote of the Commissioners present.
