

Grand Junction, Colorado
September 2, 1919

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Garber, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of August 26th were read and approved.

D. B. Wright and other members of the board of education appeared before the Council in reference to the employment jointly by the city and school district of a visiting school nurse.

The matter was discussed, but no action was taken.

A communication from the Grand Junction Town & development Co. was read and referred to the City Clerk.

The report of J. E. Ragan, submitting a statement of the gross receipts of The Grand Junction Electric, Gas & Manufacturing Co. for the sale of electric current for the years 1910 to 1918 inclusive, was submitted and read.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the report was referred to the Commissioner of Finance and Supplies with instructions to collect the difference in percentage due the City from the Grand Junction Electric, Gas & Manufacturing Co.

The montly report of the City Weigher was submitted and read and referred to the Mayor.
