Moved by Commissioner Blackstone, seconded by Commissioner Garber, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bills allowed.

Members of the Fire Department made the request to the Council to employ one extra man for the department for the next year, beginning January 1st, and that one man be allowed to be off duty for 24 hours every fourth day.

Moved by Commissioner Cherrington, seconded by Commissioner Garber, that the request be refused.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

A proposed ordinance, entitled "An Ordinance Providing for an Emergency Appropriation for the Fire Department," was introduced and read.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the proposed ordinance as read be passed and adopted as an emergency ordinance and that it be numbered 286 and ordered published.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the ordinance passed and adopted and numbered 286. A communication from the U. S. Food Administration was read and ordered filed.

The following resolution was introduced and read:

RESOLUTION

BE IT RESOLVED, by the City Council of the City of Grand Junction, Colorado, that for the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction for the next fiscal year, beginning January 1, 1920, and ending December 31, 1920, there shall be and hereby is levied and assessed upon all the taxable property situated within the corporate limits of the said city of Grand Junction, both real and personal, the following amounts for special and general taxes, to-wit:

<u>First.</u> For the purpose of defraying the expenses and maintenance of the free Public Library, a tax of four-tenths of one mill on each dollar of property so assed or to be assessed.

<u>Second.</u> For the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction and for the payment of interest on outstanding bonds and for the payment of a portion of the bonded indebtedness of said city, a tax of nine and six-tenths (9.6) mills on each dollar of said property so assessed or to be assessed; and be it further

RESOLVED, that the City Clerk be and he is hereby authorized and instructed to certify to the foregoing levy to the County Clerk and Recorder and also to the County Assessor of Mesa County, Colorado, as required by the Statutes of the State of Colorado, and as provided also by the Charter of the City of Grand Junction.

Moved by Commissioner Holmburg, seconded by Commissioner Garber, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that C. B. Rich and Henry Tupper, notaries public, and S. B. Eskridge, justice of the peace, be appointed to serve on the canvassing board, in place of Commissioners Holmburg, Blackstone and Garber, to canvass the returns of the municipal election held November 4th.

The motion carried.

On motion of Commissioner Blackstone, seconded by Commissioner Holmburg, the Council adjourned until to-morrow, November 6th, at 9 o'clock a.m.
