The City Council met at 9 o'clock a. m., as a canvassing board, C. B. Rich and Henry Tupper, notaries public, and S. B. Eskridge, justice of the peace, taking the places of Commissioners Blackstone, Garber and Holmburg, canDidates for election as Commissioners, and the Board proceeded to canvass the vote cast at the general municipal election, held November 4, 1919.
