

Grand Junction, Colorado
November 18, 1919

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Vorbeck, Blackstone, Garber, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of November 11th and adjourned session of November 12th were read and approved.

The monthly report of the City Weigher having been examined and approved by the Mayor, the same was accepted and ordered placed on file.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bills allowed.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that Tax Sale Certificate No. 15,383, for Paving District No. 2 assessments on Lot 8, Block 126, City of Grand Junction, be sold to Fred W. Halbauer for the face value thereof plus 6 per cent. from date of certificate.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Cherrington, seconded by Commissioner Vorbeck, that the City Clerk be instructed to notify the manager of the High School Athletic Association that until settlement is made with the City for use of Lincoln Park no further games of football will be allowed in the park.

The motion carried.

The following resolution was introduced and read:

RESOLUTION

WHEREAS, the City Treasurer holds a balance of \$117.68 being the profits from the sale by the city of bacon and prunes, and

WHEREAS, there is an unpaid bill of \$51.25 due the Fair Store for supplies sold the Red Cross Flue Hospital about a year ago; therefore, be it

RESOLVED, that the City Treasurer be and he is hereby instructed to pay said bill from said fund and to turn the balance into the General Fund.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

Mayor Cherrington reported to the Council that three members of the Fire Department, Gilley, Gedney and Garber, had resigned and would quit the service of the City on December 1st, and moved that their resignations be accepted.

The motion was seconded by Commissioner Vorbeck, duly put and carried by a unanimous vote of the Council.

A proposed ordinance, entitled "An Ordinance Regulating Street Traffic in the City of Grand Junction," was introduced and read.

Moved by Commissioner Cherrington, seconded by Commissioner Blackstone, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows Cherrington, yea; Vorbeck, yea; Blackstone, yea; Garber, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the proposed ordinance passed for publication.

On motion of Commissioner Blackstone, seconded by Commissioner Garber, the Council adjourned.
