The minutes of the regular meeting of February 24th were read and approved.

J. W. Milne appeared before the Council and asked permission to enclose open shed west of his transfer ware house on Colorado avenue with frame work or corrugated iron.

On motion of Commissioner Whittaker, seconded by Commissioner Blackstone, the acting Mayor and Fire Chief were appointed a special committee to investigate the matter and report findings to the Council at its next meeting.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized and instructed to renew the insurance on the City Hall for the \$5,000 policy expiring April 2d.

The motion being put, upon call of roll, the Commissioners voted as follows: Garber, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

The report of the McMahon Audit Co., on the audit of the City's books and accounts was submitted and read.

On motion of Commissioner Holmburg, seconded by Commissioner Whittaker, the Report was accepted and Ordered placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Whittaker, that the McMahon Audit Company be employed to audit the City's books and accounts for the years 1920 and 1921, semi-annual reports to be made, the City to pay \$250.00 per year for said audits.

The motion being put, upon call of roll, the Commissioners voted as follows: Garber, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

The petition of Mrs. Frank Zeller and ninety other citizens and residents of the south part of the city, calling attention to the smoke nuisance caused by the smoke stacks of the Grand Junction Electric, Gas & Mfg. Co.'s plant and asking the Council to take some action to abate said smoke nuisance, was presented and read.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the petition be referred to the City Attorney and that he be requested to prepare an ordinance providing for the abatement of the smoke nuisance mentioned in said petition.

The motion carried by a unanimous vote of the Commissioners present.

The report of the City Weigher for the month of February was submitted and read and referred to the Mayor.
