

Grand Junction, Colorado, June 8, 1920.

The City Council of the City of Grand Junction convened in regular session at four o'clock p.m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Garber, Whittaker, Blackstone, Holmburg.

City Attorney Tupper was present.

A committee from the Chamber of Commerce appeared before the Council with reference to the improvement of Washington Park for the benefit of automobile tourists.

After some discussion of the proposition, the matter was referred to the Commissioner of Health and Civic Beauty.

T. F. Flucken and other citizens of the West Side appeared before the Council in reference to the protection of the river bank from the Main street bredge to the Fifth street bridge, and presented an agreement of citizens to contribute various amounts towards the cost of the work.

After some discussion of the matter, the Council agreed to present the same to the Board of County Commissioners for joint action.

Messrs. Medders and Thompson appeared before the Council in reference to the employment of the D. & R. G. band for public concerts during the summer. The Council agreed to take up the matter at some future meeting.

The petition of John Phillips and others in reference to the disposal of the waste water from the plant of the Grand Junction Electric, Gas & Mfg. Co., was presented and read.

Moved by Commissioner Whittaker, seconded by Commissioner Holmburg, that the petition be granted, and that the Grand Junction Electric, Gas & Manufacturing Co. be requested to at once carry the waste water from their plant to the river in tile or otherwise dispose of the same so that it does not run on the surface of the ground, and that the Mayor be instructed to so notify said company.

The motion carried by a unanimous vote of the Council.

The petition of A. M. Weir, asking the extension of water main on South Seventh street, was presented and read.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the petition be granted, and that the Commissioner of Water and Sewers be instructed to extend water

main on South Seventh street, running east on Crawford avenue to lots 20 to 28, in Block 20, Milldale Subdivision, to supply said lots with water.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

All the Commissioners having voted yea, the motion was declared carried.

On motion of Commissioner Whittaker, seconded by Commissioner Blackstone, the Council adjourned.
