

Grand Junction, Colorado, June 29, 1920.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Whittaker, Blackstone, Holmburg. Absent: Commissioner Garber.

City Attorney Tupper was present.

The minutes of the regular meeting of June 22d were read and approved.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the D. & R. G. Band be employed to give five Sunday evening concerts at the city parks, the first concert to be given Sunday, July 11, the city to pay \$50.00 for each concert.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that an are light be ordered placed at the intersection of West Colorado avenue and West avenue.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

Moved by Commissioner Blackstone, seconded by Commissioner Whittaker, that J. E. Ragan be employed to go to Denver and check up the books of the Mt. States Telephone & Telegraph Co., and that Commissioner Holmburg be instructed to accompany Mr. Ragan to assist in the investigation of said books.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

Moved by Commissioner Holmburg, seconded by Commissioner Whittaker, that Commissioner Blackstone be appointed to act as City Clerk during the absence from the city of Commissioner Holmburg.

The motion carried.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized and instructed to order for the Water Department 500 feet, more or less, of 12 inch O.D. lap-welded steel pipe, converse up-joint.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

Moved by Commissioner Blackstone, seconded by Commissioner Whittaker, that the Commissioner of Water and Sewers be requested to investigate and see if there is a service pipe carrying water to the Sprott garage and other places, which service pipe will be under the paving at the intersection of Main and Seventh streets, and if there is such a service pipe, Mr. Sprott be required to replace the same with lead pipe or to make a connection that would not be under the pavement.

The motion carried.

Moved by Commissioner Whittaker, seconded by Commissioner Holmburg, that the Commissioner of Highways be instructed to place a sanitary drinking fountain in the City Hall.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Whittaker, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.
