

Grand Junction, Colorado, August 10, 1920.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Garber, Whittaker, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of August 3d were read and approved.

The report of investigation on the Grand Junction plant of the Mountain States Telephone and Telegraph Company, by J. E. Ragan, was submitted and read.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the report was accepted and ordered placed on file.

Mr. Burgess and other members of the Chamber of Commerce appeared before the Council and presented the matter of the city connecting the State concrete highways on the east and west through the city.

After some discussion, the City Attorney was instructed to draw up and amendment to the public improvement district ordinance and provide for the designation of city thoroughfares whereby the cost of paving such thoroughfares might be borne by the city as a whole in part and other part by the public improvement district.
