Mr. E. Regi was present and asked for a permit to connect with Sewer Dist. No.3 which was granted upon the payment of \$40.00

City attorney Tupper reported that the property belonging to Mr. Castell in block 149 did not extend to the North. On the South side of Pitkin Av. to conform in line with the buildings now owned by the Premium Inv. Co. and that Mr. Castell should not be permitted to extend his building beyond the original property line.

Upon request of the County Treasurer the following resolation was read

Whereas on Dec.12, 1919 the South 25ft.of the north 75ft.of lots 8 to 12 inclusive in Block 143 & the North 25 ft. of the South 50ft.of lots 8 to 12 inclusive in Block 143 were through error sold for the year 1919 and certificate Nos.21187 & 21188 were issued therefore.

Therefore be it resolved that the said certificates be turned over to the County Treasurer for cancellation.

Whereas on Dec. 14,1917 the North 50ft. of lot 3 except the east 10ft.there of in Block 122 was sold to the City and tax certificate No.20103 was issued therefore and whereas the said taxes was endorsed on tax certificate No.18794.

Therefore be it resolved that the said certificate No.20103 be turned over to the County Treasurer for cancellation.

Moved by Commissioner Whittaker second by Commissioner Blackstone the resolution be adopted as read. Upon call of roll the Commissioners voted as follows Cherrington yea, Garber yea, Blackstone yea, Whittaker yea, all Commissioners voted yea the motion was declaired carried.

Moved by Commission d Garber second by Commissioner Blackstone that the Commissioner of Finance & Supplies be instructed to purchase one ton of pig lead for the water dept. Upon call of roll the Commissioners voted as follows Cherrington yea, Garber yea, Blackstone yea, Whittaker yea, all Commissioners present voting yea the motion was declaired carried.

Moved by Commissioner Garber second by Commissioner Blackstone that the City digger be rented to Geo. E. White for \$25.00 per day any one else \$40.00 per. day the City to furnish fireman & engineer at the \$40.00 rate.

The motion was carried unanimous.
