A representative body of Business men was present to take up the mater of street lighting, Mr. Murr presented his report with checks to cover their proportion of the white way on south Fourth St. Mr. Smith made his report and said he would have all the money collected and make turn over to the City at its next regular meeting to cover that portion of the white way between Second and Third on Main St. and from Main St. to the Depot on South Second St. and also would try to line up the people between Sixth and Seventh St. on Main St. It was then agreed that Mayor Cherrington communicate with the several firms advising them that the City was ready to purchase posts and material for these extensions and request them to submit prices for the same so they could be presented at our next regular meeting. A request from Mr. Anderson, Gen. Sup't. of the Grand Junction Electric, Gas and Mfg. Co. asking permission to erect an Electric sign on the front wall of the building at 126 North Fifth St. Said sign being to long to comply with the Ordinance the permit was not granted.

Bids for the iron work for the re construction of the water main on the Fifth St. Bridge was read. Moved by Commissioner Blackstone seconded by Commissioner Garber the work be given to N. T. Nelson \$834.79. Upon call of roll the Commissioners voted as follows Cherrington yea, Garber yea, Blackstone yea, Whittaker yea, all Commissioners voting yea the Motion was declared carried and the bid accepted.

The report of the City Treasurer for the Third quarter was read and was moved by Commissioner Blackstone seconded by Commissioner Garber the report be accepted and refered to the Mayor for audit. Motion carried.

The report of the Librarian for the Third quarter was read, moved by Commissioner Blackstone seconded by Commissioner Garber the report be accepted and placed on file motion carried. The report of Highways for the Third quarter was read, moved by Commissioner Garber seconded by Commissioner Blackstone the report be referred to the Clerk for audit. Motion carried. The report of Health and Civic Beauty for the 3rd quarter was read. Moved by Commissioner Whittaker seconded by Commissioner Blackstone the report be turned over to the Mayor for audit, motion carried. The report of the Judge of municiple Court was read and on motion by Commissioner Blackstone seconded by Commissioner Garber the report be referred to the Clerk for audit, motion carried. Moved

by Commissioner Whittaker seconded by Commissioner Blackstone the Commissioner of Finance & Supplies be instructed to order assessment books for sewer Districts Nos. 5 & 6 the motion being put upon call of roll the Commissioners voted as follows Cherrington yea, Garber yea, Blackstone yea, Whittaker yea, all Commissioners voting yea the motion carried and the books ordered.
