

Grand Junction, Colorado. October 26, 1920

The City Council of the City of Grand Junction convened in regular session at 4 O'Clock P.M. with Mayor Cherrington in the chair, Commissioners present Cherrington Garber, Blackstone? Whittaker, City Attorney Tupper was present.

The meeting of October 19, was read and approved as corrected.

Mayor Cherrington made a report on the white way lighting system.

The report of Highway haveing been OK'd it was moved by Commissioner Garber, seconded by Commissioner Blackstone the report be accepted and filed motion carried.

The report of Health & Civic Beauty haveing been OK'd it was moved by Commissioner Blackstone seconded by Commissioner Garber the report be accepted and filed motion carried. The report of Commissioner Public Affairs for the third quarter was read, moved by Commissioner Blackstone seconded by Commissioner Garber the report be referred to the Treasurer, motion carried. The report of Commissioner Water and Sewers for the third quarter was read and was moved by Commissioner Blackstone seconded by Commissioner Garber the report be referred to Treasurer for check motion carried.

The report of the Auditor for the first half of the year 1920 was read and on motion of Commissioner Blackstone seconded by Commissioner Garber the report was accepted and ordered filed motion carried.
