

Grand Junction, Colorado, November 26, 1920

The City Council of the City of Grand Junction convened in regular adjourned session at Nine o'clock A.M. in the City Hall with Mayor Cherrington in the chair. On call of roll the following Commissioners responded as present: Cherrington, Garber, Blackstone and Whittaker. City Attorney Tupper was also present.

The following resolution was introduced and read:

RESOLUTION

WHEREAS under the terms and provisions of ordinance No. 178 as amended, the City Council has created Sanitary Sewer District No. 5 of the City of Grand Junction and the said City Council has caused to be published as required by said ordinance as amended, a notice of the completion of said district and apportionment of the cost thereof, and

WHEREAS, J. A. K. Crawford has filed an objection in writing to the assessment thereon, and

WHEREAS, in the opinion of the City Council the objection of said Crawford to the assessment against lots one (1) to eighteen (18) inclusive in block two (2) of Crawford's Subdivision to the City of Grand Junction, is valid, the said lots being not benefited from said sewer, and

WHEREAS, in the opinion of the City Council the remainder of said objection is without foundation.

THEREFORE BE IT RESOLVED that said lots one (1) to eighteen (18) inclusive in block two (2) of Crawford's Subdivision be exempt from assessment in said Sewer District No. 5, and that the remainder of the objections of the said Crawford to the assessment in Sewer District No. 5 be, and the same is hereby overruled and

BE IT FURTHER RESOLVED that the time under said ordinance as amended for filing objections against the acceptance of said work and the assessment therefor has now expired and the said apportionment is hereby confirmed with the exception of the assessment on lots one (1) to eighteen (18) inclusive in block two (2) as aforesaid all being in pursuance of said ordinance No. 178 as amended.

Moved by Commissioner Blackstone, seconded by Commissioner Garber that the resolution as read be passed and adopted. The motion being put on call of roll, the Commissioners voted as follows: Cherrington, yea, Garber, yea, Blackstone, yea, Whittaker, yea; all the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The following resolution was then introduced and read;

RESOLUTION

WHEREAS, under the terms and provisions of Ordinance No. 178 as amended, the City Council has created intercepting Sewer District No. 6, of the City of Grand Junction, Colorado and the said City Council has caused to be published, as required by said ordinance, a notice of the completion of said district and apportionment of the cost thereof; and

WHEREAS, no written objections, or any other objections, have been filed with the clerk with respect to the proposed assessment of cost for said improvements;

THEREFORE BE IT RESOLVED that the time under said ordinance for filing objections of any kind against the acceptance of said work, and the assessment therefor, has now expired and the said apportionment is hereby confirmed, all being in pursuance of said ordinance as amended.

Moved by Commissioner Garber, seconded by Commissioner Blackstone that the resolution as read be passed and adopted. The motion being put on call of roll, the Commissioners voted as follows: Cherrington, yea, Blackstone yea, Garber, yea, Whittaker, yea. All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The proposed Ordinance entitled:

"AN ORDINANCE APPROVING THE WHOLE COST OF THE IMPROVEMENTS MADE IN AND FOR SANITARY SEWER DISTRICT NUMBER FIVE, IN THE CITY OF GRAND JUNCTION, COLORADO PURSUANT TO ORDINANCE NO. 178, as amended, AND PURSUANT TO THE RESOLUTIONS AND PROCEEDINGS OF THE CITY COUNCIL, ADOPTED PURSUANT TO SAID ORDINANCE NO. 178, as amended, APPROVING THE APPORTIONMENT OF SAID COST TO EACH LOT OR TRACT OF LAND IN SAID DISTRICT; ASSESSING A SHARE OF SAID COST AGAINST EACH LOT OR TRACT OF LAND IN SAID DISTRICT AND PRESCRIBING THE MANNER FOR THE COLLECTION AND PAYMENT OF SAID ASSESSMENT."

was introduced and read. Moved by Commissioner Blackstone, seconded by Commissioner Garber that the proposed ordinance as read be passed for publication. The motion being put upon call of roll, the Commissioners voted as follows: Cherrington, yea, Blackstone, yea, Garber, yea, Whittaker, yea. All the Commissioners having voted yea, the Mayor declared the motion carried, and the proposed ordinance passed for publication.

GRAND JUNCTION, COLORADO, PURSUANT TO ORDINANCE NO. 178, as amended, AND PURSUANT TO THE RESOLUTIONS AND PROCEEDINGS OF THE CITY COUNCIL, ADOPTED PURSUANT TO SAID ORDINANCE NO. 178, as amended, APPROVING THE APPORTIONMENT OF SAID COST TO EACH LOT OR TRACT OF LAND IN SAID DISTRICT, ASSESSING A SHARE OF SAID COST AGAINST EACH LOT OR TRACT OF LAND IN SAID DISTRICT AND PRESCRIBING THE MANNER FOR THE COLLECTION AND PAYMENT OF SAID ASSESSMENT.

was introduced and read. Moved by Commissioner Blackstone, seconded by Commissioner Garber that the proposed ordinance as read be passed for publication. The motion being put upon call of roll, the Commissioners voted as follows: Cherrington, yea, Blackstone, yea, Garber, yea, Whittaker, yea. All the Commissioners having voted yea, the Mayor declared the motion carried and the proposed ordinance passed for publication.

was presented and read. Moved by Commissioner Blackstone, seconded by Commissioner Garber that the Proof of Publication

as read be accepted and placed on file, and that the proposed ordinance be taken up for final passage, motion carried and was so ordered. The proposed ordinance was thereupon read by the Clerk. It was moved by Commissioner Blackstone, seconded by Commissioner Whittaker, that the proposed ordinance as read and entitled:

"THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION FOR THE FISCAL YEAR BEGINNING JANUARY 1st, A. D. 1921 AND ENDING DECEMBER 31st, A. D. 1921"

be passed and adopted, and numbered No. 295. The motion being put upon call of roll, the Commissioners voted as follows: Cherrington, yea, Blackstone, yea, Garber, yea, Whittaker, yea. All the Commissioners having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted and numbered 295.
