Grand Junction, Colo. Feb. 1, 1921

The minutes of the last regular meeting were read and approved.

Charles Lumley made application as pound master, relieving E.W. Wright of this position. Moved by Commissioner Whittaker, second by Commissioner Peck that Charles Lumney be appointed in E.W. Wright's place. Motion carried.

The resignation of Andrew L Halligan as a salaried city policeman was presented. Moved by Commissioner Whittaker, Second by Commissioner Garber that the resignation be accepted, and that the Mayor use his discretion in issuing Mr. Halligan a Police commission without pay. Motion carried.

A motion was put by Commissioner Whittaker, seconded by Commissioner Garber that the term of Henry Hale as janitor of the City Hall be terminated at once. Motion carried.

The application of TJ Flynn requesting the position as janitor of the City. Hall was considered. Moved by Commissioner Garber seconded by Commissioner Peck that T.J. Flynn be appointed to fill Mr. Hale's place. The appointment to take place at once. Motion carried.

Mr. Sharer of the Grand Junction Town and Development Co. came before the council asking for certain reductions on tax certificates redeemed by the company. Upon consideration of this request Commissioner Whittaker move, seconded by Commissioner Garber, that the tax certificates sold to The Grand Junction Town and Development Company in the future, the interest on the first sale shall be waived, and that the interest on the actual indorsement shall be charged at the rate of six percent (6%) compounded annually. The motion being put, upon call of roll the Commissioners present voted as follows; Commissioner Cherrington, yea, Commissioner Garner, yea, Commissioner Whittaker, yea, Commissioner Peck, yea, All the Commissioners present voting yea, the motion was declared carried.

The selling of the Segrave Fire Truck after the arrival of the LeFrance pumper was considered. Moved by Commissioner Whittaker, seconded by Commissioner Garber that the truck be ordered sold for the sum of Seventeen hundred and fifty dollars. (1750.00), and allowing One hundred fifty dollars commission (\$150.00) on the sale. The motion being put, upon call of roll the

Commissioners present voted as follows; Cherrington, yea, Whittaker, yea, Garber, yea, Peck, yea. All Commissioners present voting yea, the motion was declared carried.

The bond of J.W. Rader after being approved by City Attorney Tupper was accepted and ordered filed.
