

Grand Junction Colo. Feb. 8, 1921

The regular meeting of the City Council of the City of Grand Junction Colo. was called to order at 3:30 o'clock P.M., with Mayor Cherrington in the chair.

The Commissioners present were, Cherrington, Garber, Whittaker, and Peck. Commissioner Blackstone was absent. City Attorney Tupper was present.

The minutes of the last meeting were read and approved.

Mrs. Harry Jones appeared before the Council in behalf of the Cemetery Improvement Association, asking for a donation to be used for the improvement and up-keep of the Orchard Mesa Cemetery. Moved by Commissioner Whittaker, seconded by Commissioner Garber that a warrant be drawn in favor of the Cemetery Improvement Association for One Hundred Dollars (100.00) such moneys to be used for improvement and upkeep of the Orchard Mesa Cemetery. The motion being put, upon call of roll the Commissioners present voted as follows; Cherrington, yea, Garber, yea, Whittaker, yea, Peck, yea. All the Commissioners present voting yea the motion was declared carried and the warrant ordered drawn.

The motion regarding the installation of arc lights on the corners of 3rd Ave and Seventh and on Nolan and Seventh was next in order. Moved by Commissioner Whittaker second by Commissioner Peck that the Mayor notify the Electric Company to install one four hundred candle power arc light on each of the aforesaid corners. Motion carried.

Moved by Commissioner Peck seconded by Commissioner Garber that the license for one pool table be transferred from Henry Garcia to Antonio Antonez. Motion carried.

The annual reports of the Commissioner of Public Affairs and of the Judge of the Municipal Court were read. Moved by Commissioner Whittaker, second by Commissioner Garber that the reports be referred to the Auditor for audit. Motion carried.
