Grand Junction, Colo.

March 1, 1921

A regular meeting of the City Council of the City of Grand Junction convened at 3:15 P.M. with Act. Mayor Garber presiding. The Commissioners present were Garber, Whittaker, Blackstone, Peck. Commissioner Cherrington was absent. City Attorney Tupper was present.

The minutes of the last regular session were read and approved.

J.W. Spencer, district forest supervisor, appeared before the council and asked that the contract entered into between the U.S. Department of Agriculture and the City of Grand Junction for the protection of the Kannah Creek water shed be amended. In consideration of this matter the following resolution was introduced and read.

RESOLUTION

WHEREAS The City of Grand Junction, Colorado on June 16 1915 entered into a contract with the U.S. Department of Agriculture for the purpose of conserving and protecting the water supply of the City on the water shed of Kannah Creek, and

WHEREAS The said contract limited the number of stock to be grazed thereon to 2500 head of cattle, horses and mules which was the number such stock permits on said range in 1915 and each year subsequent thereto, and

WHEREAS It now appears that the grazing capacity of said range is in excess of 2500 head and that a very material number more than said 2500 have been annually grazed thereon for years.

NOW THEREFORE BE IT RESOLVED That the City does hereby consent to approve the pasturage on said range, of cattle, horses and mules, in excess of 2500 head up to the reasonable grazing capacity of said range.

Moved by Commissioner Whittaker seconded by Commissioner Blackstone, that the resolution as read be passed and adopted. The motion being put, upon call of roll the Commissioners present voted as follows, Garber, yea, Whittaker, yea, Blackstone, yea Peck yea. All the Commissioners present voting yea the motion was declared carried.

The Commissioner of Highways presented a requisition for one work horse for the use of his Department.

Moved by Commissioner Whittaker, second by Commissioner Peck that the Commissioner of Finance and Supplies be instructed one good work horse for the use of the Highways Department. The motion being put, upon call of roll the Commissioners present voted as follows. Garber, yea, Whittaker, yea, Blackstone, yea, Peck, yea. All the Commissioners present voting yea the motion was declared carried.

The Commissioner of Health and Civic Beauty requested the purchase of 800 feet, more or less of garden hose for use in the City Parks.

Moved by Commissioner Blackstone, second by Commissioner Whittaker that the Commissioner of Finance and Supplies be instructed to purchase 800feet, more or less, of 3/4 inch garden hose for use in the City Parks. The motion being put, upon call of roll the Commissioners present voted as follows, Garber, yea, Whittaker, yea, Blackstone, yea Peck, yea. All the Commissioners present voting yea the motion was declared carried and the purchase authorized.

The question of exempting certain lots in Block 5 Crawford Subdivision, of sewer as tax was next brought up. These lots border on the Grand River and are undesirable building locations. Moved by Commissioner Whittaker, second by Commissioner Blackstone that lots: 11, 12, 13, 14, and 15 all in Block 5 Crawford Sub-division and in Sanitary Sewer District No. 5, be exempt from sewer assessment. The motion being put, upon call of roll the Commissioners present voted as follows, Garber, yea, Whittaker, yea, Blackstone, yea, Peck, yea. All the Commissioners present voting yea the motion was declared carried.

Moved by Commissioner Whittaker, seconded by Commissioner Blackstone that the reports be referred to the Commissioner of Finance and Supplies for audit. Motion carried.
