Grand Junction, Colo.

March 22, 1921

The City Council of the City of Grand Junction, Colo. convened irregular session at 3:30 P.M. with acting Mayor Garber presiding. The Commissioners present were Garber, Whittaker, Blackstone, Peck. Commissioner Cherrington was absent. City Attorney Tupper was present.

The minutes of the last regular session were read and approved.

County Commissioners Johnson, Jones and Wallace, met with the Council along with others interested in the protection of the Main Street bridge and of the property adjacent thereto.

A resolution passed by the State Highway Commission regarding the appropriation for river work above the Fifth Street bridge was read. This resolution stating that the State Highway Commission would expend \$10,000 for protection work above the Fifth Street bridge providing the City and County would expend the same amount above the Main Street bridge.

The following resolution was then read.

RESOLUTION

WHEREAS the State Highway Commission has appropriated Ten Thousand Dollars, (\$10,000) for protective work above the Fifth Street bridge on condition that the County of Mesa and the City of Grand Junction expend an equal sum for the protective work above the Main Street bridge, and

WHEREAS the County Commissioners of Mesa County and the City of Grand Junction are willing to accept the said proposition and do the necessary protective work above the Mains Street bridge, and

WHEREAS it is necessary because of approaching high water to do the work at once,

THEREFORE BE IT RESOLVED that the City Council does agree with the County of Mesa to do the necessary protective work above the Main Street bridge. The work to be done at once under the supervision of T.E.Thomson the City Engineer and the County Engineer and that the expense be paid in equal portions by the City of Grand Junction and the County of Mesa, and

BE IT FURTHER RESOLVED that the character of the protective work be determined by the Chairman of the Board of County Commissioners, the Commissioner of Highways of said city and the said Thompson; that the wage scale shall be 40 cents per hour for single hand labor and 70 cents an hour for man and team. Moved by Commissioner Whittaker, seconded by Commissioner Garber, that the resolution as read; be passed and adopted. The motion being put upon call of roll the Commissioners voted as follows, Garber, yea, Whittaker, yea, Blackstone, yea, Peck, yea. All the Commissioners present voting yea the motion was declared carried.
