Grand Junction, Colo. April 12, 1921

The regular meeting of the City Council of the City of Grand Junction was called to order at 3:30 P.M. with Mayor Cherrington presiding. The Commissioners present were Cherrington, Whittaker, Garber, Blackstone, Peck. City Attorney Tupper was also present.

The minutes of the last regular session were read and approved.

Acting upon the Mayor's recommendation the City Clerk was ordered to notify the Electric Co. to install a 600 candle power are light at the intersection of Belford Ave. and Sixth Streets.

Upon the Mayor's recommendation the Chocolate Shop and the Ideal Cleaning Parlors were granted a permit to install electric signs at their respective places of business. Said signs to confirm with the City Ordinances governing the erection of signs.

The following resolution was read.

Moved by Commissioner Whittaker, second by Commissioner Blackstone that the resolution be passed and adopted as read. The motion being put, upon call of roll the Commissioners voted as follows, Cherrington, yea; Garber, yea: Whittaker, yea: Blackstone, yea; Peck, yea. All the Commissioners voting yea the motion was declared carried.

Moved by Commissioner Peck, second by Commissioner Whittaker that the bonds of J.C. Schmidt and Frank Clifton, policemen, having been approved by City Attorney Tupper be accepted and ordered filed. Motion carried.

The following supplies were requisitioned by the Commissioner of Public Affairs:

2000 feet #8 B&S Gauge Stranded Twin Conductor Park Cable, each conductor insulated with 5/64" wall, with national Electric code Standard Rubber insulation- separately taped- rounded up with jute- leaded -tarred jute over lead- two steel tapes, each .030" thick, with tarred jute over all, suitable for 3500 volts working pressure, \$271.00 per M feet, F.O.B. Wilkes Barre, Pa. freight allowed to Mississippi river. Terms- 1%- 10-30 days net.

Moved by Commissioner Cherrington, second by Commissioner Peck that the Commissioner of Finance and supplies be authorized and instructed to purchase the above quoted supplies. The motion being put, upon call of roll the Commissioners voted as follows, Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea: Peck, yea. All the Commissioners voting yea. The motion was declared carried.

The question of the purchase of one pair of truck scales was brought up. Moved by Commissioner Blackstone, second by Commissioner Garber that the Commissioner of Finance and Supplies investigate as to the best prices on scales and report to the Coun-l at the next regular meeting. Motion carried.

The Commissioner of Highways presented a requisition for one motor sprinkler for use in his department. Moved by Commissioner Blackstone, second by Commissioner Garber that the Commissioner of Finance and supplies be authorized and instructed to purchase:

One Chevrolet Truck Chassis equipped with drivers seat, windshield, electric lights, electric starter, electric horn, complete tool equipment,  $32 \times 4$  dual Sewell Cushion Wheels on rear and 4" Goodyear Solid Tires,  $33 \times 4$  Goodyear Allweather Tread Cond tires on front wheels. Chassis to be equipped with Alemite Lubricating System.

A 650 gallon tank 39"  $\times$  120" built to carry 85lbs. pressure, equipped with 15" manhole, a 20" gage glass, a 100 lb. pressure gage, a 1" release valve and gear and horizontal discharge heads. The above mentioned chassis and equipment as described to be delivered for the sum of Twenty-three Hundred and Fifty Dollars. (\$2,350.00).

The motion being put, upon call of roll the Commissioners voted as follows: Cherrington, Yea; Garber, yea; Whittaker, nay; Blackstone, Yea; Peck, nay. The majority of the Commissioners voting yea, the motion was declared carried and the purchase authorized.

Moved by Commissioner Peck, second by Commissioner Whittaker that the Commissioner of Finance and Supplies be authorized and instructed to purchase 68 gallons, more or less of house paint, 150 gallons, more or less, of roof paint, 200 lbs. cold water paint, and 20 gallons, more or less of linseed oil, for use of the Park Department. The motion being put upon call of roll, the

Commissioners voted as follows: Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea; Peck, yea. All the Commissioners voting yea, the motion was declared carried.
