

Grand Junction, Colo.
April 20, 1921.

A regular meeting of the City Council was called to order at 3:30 P.M. with Mayor Cherrington presiding. The Commissioners present were Cherrington, Garber, Whittaker, Blackstone, and Peck. City Attorney Tupper was present.

The minutes of the last regular session were read and approved.

A petition signed by F.A. Meyers and others was presented. The petition requested that a arc light be installed on the corner of Ute Ave. and Twelfth Street. Moved by Commissioner Blackstone, seconded by Commissioner Garber; that the petition be referred to the Mayor for investigation. Motion carried.

The report of J.E. Ragan, public accountant, on the audit of the city's books for the last half of the year 1920 was read. Moved by Commissioner Peck, second by Commissioner Blackstone that the report be accepted as read. Motion carried.

Moved by Commissioner Garber, second by Commissioner Blackstone, that the matter pertaining to the 3% paid to the City by the Grand Junction Electric, Gas and Mfg. Co., for current used and which in the opinion of J.E.Ragan does not satisfy the provisions of the ordinance passed by the city Council on December 16 1919: be turned over to the City Attorney for investigation. Motion carried.

Moved by Commissioner Whittaker, second by Commissioner Peck that the Commissioner of Finance and Supplies be authorized and instructed to purchase the following for the use of the Park Department.

1115 feet-8" sewer tile.
510' feet-4" sewer title.
250 feet-6" sewer tile.
2 6 x 4-y's.
1 4 x 4-y.

The motion being put, upon call of roll the Commissioners voted as follows; Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea; Peck, yea. All the Commissioners voting yea, the motion was declared carried.

Moved by Commissioner Garber, second by Commissioner Blackstone that the Commissioner of Water and Sewers lay a 2" water main on Main Street between 14 and 15 Streets, and also between 7th and 8th Streets on Belford Avenue. Motion carried.

Moved by Commissioner Garber, Seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized and instructed to purchase 1000 feet of galvanized 2

inch water pipe for the use of the Water Department. The motion being put upon call of roll, the Commissioners voted as follows: Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea; Peck, yea. All the Commissioners voting yea, the motion was declared carried.

The following quarterly reports were read. Report of the Commissioner of Finance and Supplies, report of the Commissioner of Water and Sewers, report of the Commissioner of Highways, and the report of the Municipal Judge. Moved by Commissioner Peck, second by Commissioner Blackstone that the reports be referred to the Auditor for audit. Motion carried. The reports of the City Clerk and Auditor and the Commissioner of Health and Civic Beauty were read. Moved by Commissioner Blackstone second by Commissioner Garber that the reports be turned over to the City Treasurer for audit. Motion carried.
