Grand Junction, Colo. May 17, 1921

The regular meeting of the City Council of the City of Grand Junction, Colo. convened in regular session at 3:00 o clock P.M. with Mayor Cherrington presiding. The Commissioners responding present were, Cherrington, Garber, Whittaker, Blackstone, and Peck. City Attorney Tupper was not present.

The minutes of the last regular session were read and approved.

A communication from R.E. Tops requesting the city to purchase flags with which to decorate the streets during the Christian Endeavor Convention was read. D.B. Wright and Bert Sampliner were present asking for a similar request. These gentlemen were assured by the council that the matter would be given consideration and that the purchase of the flags would be taken up at the next regular meeting.

Moved by Commissioner Garber, second by Commissioner Peck that the Commissioner of Finance and Supplies be instructed to have the necessary repairs made on the chlorine apparatus, said repairs to cost \$175.00. The motion being put, upon call of roll the Commissioners voted as follows, Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea; Peck, yea. All the Commissioners voting yea, the motion was declared carried.

Moved by Commissioner Whittaker, second by Commissioner Peck that the City Offices be closed during Saturday the months of June, July, August, and September. Motion carried.

Moved by Commissioner Peck, second by Commissioner Blackstone that the license granted M.Magaki for four pool tables be transferred to Mrs. T. Hagashi. Motion carried.

Moved by Commissioner Peck, second by Commissioner Blackstone that F.B. Ellison be given permission to erect a sign at his place of business, said sign to confirm with the City Ordinances and to be erected only on the recommendation of the Mayor. Motion carried.

A petition signed by A.D. Colescott and others was read. The petition requested certain improvements to be made on the South Side. Moved by Commissioner Blackstone second by Commissioner Peck that the petition be accepted and filed and that the improvements asked for be referred to the Heads of the different department for their investigation and recommendation. Motion carried.

The petition of Mrs. Amanda Armstrong et al requesting the installation of an arc light at the intersection Fifth Street and Teller Avenue was presented. Moved by Commissioner Garber, second by Commissioner Peck that the petition be referred to the Mayor for his recommendation. Motion carried.

A communication from The Denver and Rio Grande Railroad Company in reference to damage claims on broken sewer tile was read. The letter stated that the Railroad Company was willing to settle on a 50-50 basis. Moved by Commissioner Peck, second by Commissioner Blackstone that this matter br turned over to City Attorney Tupper and Commissioner Whittaker for their decision. Motion carried.

A communication from Price and McDonald of Denver protesting against the paving of Main Street was read. The letter was placed in the files for future reference.

A letter from the firm of Sidlo, Simon and Fels wof Denver in reference to the condition of the bond marker and advising the postponement of the paving of Main Street until next year was read. The letter was filed for reference.

The quarterly report of the librarian for the first quarter of 1921 was read. Moved by Commissioner Peck, second by Commissioner Blackstone that the report be accepted and filed. Motion carried.

Due to the absence of the City Attorney the matter pertaining to the abandonment of the irrigation ditch situated in the north east part of the city was postponed until the next regular meeting.
