

Grand Junction, Colo.
June 21, 1921

The City Council of the City of Grand Junction, Colo. met in regular session at 4:00 o'clock P.M. with Mayor Cherrington presiding. The Commissioners present were Cherrington, Garber, Whittaker, Blackstone and Peck. City Attorney Tupper was present.

The minutes of the last regular session were read and approved.

The proof of publication of the proposed ordinance entitled "an ordinance amending section 2 of ordinance No. 132 passed and adopted November 8 1905" was read. Moved by Commissioner Garber, second by Commissioner Blackstone that the ordinance be passed as read and numbered 300. The motion being put, upon call of roll the Commissioners voted as follows: Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea; Peck, yea. All the Commissioners voting yea the motion was declared carried and the ordinance adopted.

Moved by Commissioner Blackstone, second by Commissioner Whittaker that the Commissioner of Finance and Supplies be authorized and instructed to purchase five (5) barrels of Tarvia "k" "P". The motion being put, upon call of roll the Commissioners voted as follows: Cherrington, yea; Garber, yea; Whittaker, yea; Blackstone, yea; Peck, yea. All the Commissioners voting yea the motion was declared carried.
