

Grand Junction, Colo.  
July 19, 1921.

A meeting of the City Council of the City of Grand Junction met in regular session at 4.00 P.M. with Mayor Cherrington presiding. The Commissioners present were Cherrington, Garber, Blackstone, and Peck. City Attorney Tupper was absent. Commissioner Whittaker was also absent.

The minutes of the last regular session were read and approved.

Moved by Commissioner Peck, second by Commissioner Blackstone that the Commissioner of Finance and Supplies be authorized and instructed to purchase one ton of pig lead at \$6.40 per 100. The motion being put, upon call of roll the commissioners present voted as follows: Cherrington, yea; Garber yea; Blackstone, yea; Peck, yea. All the Commissioner voting yea the motion was declared carried.

The report of the Liabrian for the second quarter was read. Moved by Com. Blackstone, second by Commissioner Peck that the report be accepted and filed. Motion carried.

The report of the Highway Dept., Water and Sewers Dept, and the report of the City Treasurer were read. Moved by Commissioner Blackstone, second by Commissioner Peck that the reports be referred to the City Auditor for Audit. Motion carried.
