Grand Junction, Colorado July 26, 1921

The City Council of the City of Grand Junction, Colo. Met in regular session at 4:PM with Mayor Cherrington presiding. The Commissioners present were, Cherrington, Garber, Blackstone, and Peck. Commissioner Whittaker was absent. City Attorney Tupper was present.

The minutes of the last regular session were read and approved.

The proof of publicating an ordinance entitled "An Building Ordinance and also Concerning the Storage of Handling Gasoline" was presented and read.

On motion or Commissioner Peck, second by Commissioner Blackstone that the proof of publication was accepted and ordered placed on file.

Moved by Commissioner Peck, second by Commissioner Blackstone that the proposed ordinance be taken up for final passage. The motion carried and the proposed ordinance was then read by the clerk.

Moved by Commissioner Peck, second by Commissioner Garber that Section 54 of the proposed ordinance be amended to read as follows:

Sec. 54. All electrical construction, all material and all appliances used in connection with electrical work and the operation and arrangement of all electrical apparatus shall be in conformity with the rules and regulations set down in the current issue of what is known as the "National Electrical Cold", as the same is now established and said rules and regulations are hereby approved.

The motion being put upon call of roll the Commissioners present voted as follows: Cherrington, yea; Garber, yea; Blackstone, yea; Peck, yea. All the Commissioners voting yea, the motion was declared carried.

Moved by Commissioner Peck, second by Commissioner Blackstone that the proposed ordinance as read and amended and entitled "A Building Ordinance and also Concerning the Storage and Handling of Gasoline" be passed and adopted and numbered 301. The motion being put upon call of roll, the Commissioners present voted as follows: Cherrington, yea; Garber, yea; Blackstone, yea; Peck, yea. All the Commissioners present voting yea, the motion was declared carried and the ordinance passed and adopted and numbered 301.

A petition signed by the majority of the business men and merchants along Main Street requesting that Main Street between Third and Sixth Street be closed to traffic (excepting street railway service) from 7 P.M. to 12 P.M. during Sept. 7th, 8th, & 9th.

Moved by Commissioner Peck, second by Commissioner Blackstone; that the request of the petition, be granted. Motion carried.

The quarterly report of the Judge of the Municipal Court and the report of the Commissioner of Public Affairs was presented and read. On motion of Commissioner Peck, second by Commissioner Garber, the reports were referred to the Auditor for audit.

The quarterly reports of the Commissioner of Water and Sewer, having been examined and approved by the Auditor were ordered accepted and filed.

The resignation of J. F. Whittaker, Commissioner of Finance and Supplies was presented and read. It was moved by Commissioner Peck and seconded by Commissioner Garber that the resignation be accepted and filed. Motion carried.

The applications of A. L. Gex, Lulu Lynch, Mrs. G. L. Hardenburg and Frank C. Luellen for the position of Commissioner of Finance and Supplies were presented and read. Moved by Commissioner Peck, second by Commissioner Blackstone that the applications be accepted and placed on file for future reference. Motion carried.

The following bills having been examined and approved by the heads of the different departments were read.
