

Grand Junction, Colo.
September 13, 1921

A regular meeting of the City Council of the City of Grand Junction convened at 4:00 o'clock P.M. with Mayor Cherrington presiding. The commissioners present were Cherrington, Garber, Peck and Blackstone. City Attorney Tupper was present.

The minutes of the last regular session were read and approved.

Manager Stummel of the Mountain States Telephone and Telegraph Company was present on the request of the Council to explain the cause of the slow and inefficient service given telephone subscribers during the past few months. Manager Stummel stated that the Company were now installing more equipment to take care of the increased business.

The proof of publication of the proposed ordinance entitled, "An ordinance levying a special assessment on certain real estate in Grand Junction for benefits conferred by the water works of said City", was read. Moved by Commissioner Peck, second by Commissioner Garber that the proof of publication be accepted and placed on file. Motion carried.

Moved by Commissioner Blackstone, second by Commissioner Peck that the proposed be taken up for final passage. Motion carried. The proposed ordinance was then read by the Clerk. Moved by Commissioner Peck, second by Commissioner Blackstone that the proposed ordinance entitled, "AN ORDINANCE LEVYING A SPECIAL ASSESSMENT ON CERTAIN REAL ESTATE IN GRAND JUNCTION FOR BENIFITS CONFERRED BY THE WATER WORKS OF SAID CITY" be passed and adopted as read and numbered 302. The motion being put, upon call of roll the Commissioners voted as follows, Cherrington, yea; Garber, yea; Peck, yea; Blackstone yea. All the Commissioners voting yea, the motion was declared carried and the ordinance adopted.

The report of the City Weigher for the month of August was presented and read. Upon motion of Commissioner Peck, second by Commissioner Garber the report was accepted and placed on file.
