The report of the City Weigher was read. Moved by Commissioner Peck, seconded by Commissioner Garber, that the report be accepted and filed. Motion carried.

Moved by Commissioner Peck, seconded by Commissioner Garber that the Mayor and act. City Clerk be authorized to enter into a contract with the Town of Fruita, for the lease of the Ford Fire Truck and equipment, at the rate of Five (5) Dollars per month to January 1st. 1922. The Town of Fruita binding themselves in this agreement to buy said truck after the 1st. of January for the sum of Fifteen Hundred Dollars (\$1500.00); and to pay for the said truck as follows:

The sum Three Hundred Dollars (\$300.00) on May 1, 1922

Four Hundred Dollars (\$400.00) on May 1, 1923

Four Hundred Dollars (\$400.00) on May 1, 1924

Four Hundred Dollars (\$400.00) on May 1, 1925

All payments to bear interest at the rate of six percent (6%) per annum.

The motion being put, upon call of roll the Commissioners voted as follows Cherrington, yea; Garber, yea; Peck, yea; Blackstone, yea. all the Commissioners voting yea, the motion was declared carried.
