A.D. 1922, to-wit" be inserted before the word "First" and that the proof of publication as corrected be accepted and filed. Motion carried.

An ordinance entitled "the Annual Appropriation Ordinance of the City of Grand Junction, Colo., provining for the expenses and liabilities of the City of Grand Junction for the fiscal year beginning January 1st A.D. 1922 and ending December 31st A.D. 1922 was read by the clerk. Moved by Commissioner Peck, seconded by Commissioner Garber that the ordinance as read be passed and adopted and numbered 302. The motion being put, upon call of roll the Commissioners voted as follows, Cherrington, yea; Garber, yea; Peck, yea; Blackstone, yea; Fonder, yea. All the Commissioners voting yea, the motion was declared carried and the ordinance thereby adopted.
