

Grand Junction, Colo.

(No Date. Between Dec. 13, 1921 & Dec. 27, 1921)

The City Council of Grand junction met in regular session at 4:00 P.M. with Mayor Cherrington presiding. The Commissioners present were Cherington, Garber, Peck, Blackstone and Fonder. The city Attorney was also present.

The minutes of the last regular session were read and approved.

Moved by Commissioner Fonder, seconded by Commissioner Peck that the Commissioner of Finance be instructed to apply to the Secretary of State for special licenses for motor vehicles owned by the city. Motion carried.

Moved by Commissioner Peck, seconded by Commissioner Blackstone, that we recommend to the incoming council that the parking regulations in the congested district be marked plainly by being painted and that the regulations be enforced by the city authorities, as per request of the Lions -Club. Motion carried.

The City Council having Made a deMand on the Fair Association for the 10% amounting to about \$700.00 due the city from the Association from the sale of tickets during the fair week. A communication was read from Secretary Wood of the Fair Association, stating that there was no money in the treasury with which to pay the demand. No further action was taken by the council.

Moved by Peck, seconded by Garber, that the report of the auditor be referred to City Treasurer. Motion carried.

Moved by Garber, seconded by Peck that the Quarterly report of Commissioner of Health and Civic Beauty be referred to City Treasurer. Motion carried.

Moved by Peck, seconded by Garber, that the report of Commissioner of Highways be referred to the Auditor. Motion carried.

Moved by Peck, seconded by Blackstone, that the report of Commissioners of water and sewers be referred to the auditor. Motion carried.

Moved by Peck, seconded by Fonder that Oscar Gervais be allowed a temporary permit to erect an electric sign at the Milne Building on Colorado Avenue on payment of \$1.00. Motion carried.
