

Grand Junction, Colo.
December 6, 1921

The City Council of the City of Grand Junction met in regular session at 4:00 P.M. with Mayor Cherrington presiding. The Commissioners present were Cherrington, Garber Peck, Blackstone and Fonder. City Attorney Tupper was absent.

The minutes of the last regular session were read and approved.

The report of the Fire Chief for the month of November was read and approved and ordered filed.

The report of the City treasurer for the third quarter having been O.K.ed by the Auditor was ordered filed.

Moved by Commissioner Peck, seconded by Commissioner Blackstone that Billie the "Newsie" be permitted by revocable permit to erect a news stand on wheels at Sampliner's corner on South Fourth Street, providing that he has the consent of the property owners. Motion carried.

Moved by Commissioner Fonder, seconded by Commissioner Peck that the Commissioner of Finance and Supplies be authorized to purchase an Addressograph machine at the cost of \$190.00 more or less. The motion being put, upon call of roll the Commissioners voted as follows, Cherrington, yea; Garber, yea; Peck, yea; Blackstone, yea; Fonder, yea. All the Commissioners voting yea, the motion was declared carried.

Moved by Commissioner Fonder, seconded by Commissioner Blackstone that the Mayor and Commissioner of Finance and Supplies wait on the Secretary and Treasurer of the Fair Association and demand an accounting on the amount due the City from the gate receipts taken in at the County Fair held in the fall of the year 1921. Motion carried.

Moved by Commissioner Garber, seconded by Commissioner Fonder that the Commissioner of Finance and Supplies be instructed to collect the amount due from John Fuite for the use of the City digger. The amount being \$262.50. Motion carried.
