

MINUTES
January 11, 1922

Adjourned Meeting

The City Council of the City of Grand Junction met in adjourned session at 7:30 o'clock with President Hirons presiding. The Councilmen present were Hirons, Marshall, Miller, Dowrey, Meders and Murr. City Manager Cherrington, the City Attorney and the City Clerk were also present.

The minutes of the last regular session were read and approved.

A proposed ordinance entitled "An emergency ordinance concerning salaries of certain city officers and employees and fixing the amount of the bond to be given by each of said officers and employees" was presented and read.

Moved by Councilman Murr, seconded by Councilman Marshall, that the proposed ordinance entitled "An emergency ordinance concerning salaries of certain city officers and employees and fixing the amount of the bond to be given by each of said officers and employees" be passed and adopted as an emergency ordinance and that the same be numbered "Ordinance 303" and published in the Daily News, a daily newspaper published and in general circulation in the City of Grand Junction. The motion being put, upon call of roll the Councilmen voted as follows: Hirons, yea; Marshall, yea; Miller, yea; Dowrey, yea; Mderes, yea; Murr, yea. All the Councilmen voting yea, the motion was declared carried.

A communication from E.C. Sharer representing the Grand Junction Town and Development Company that requested the buying of the tax certificates held by the City on the same terms as made by the old Council, was read by the Clerk.

Moved by Councilman Murr, seconded by Councilman Marshall, that the City Clerk notify Mr. Sharer that an extension would be granted him until January 15, 1922 in which he could redeem said tax certificates for the face of the certificates and that the certificates held for water main tax be cancelled. This offer to be final and after January 15, 1922 all certificates redeemed would be sold for the face of the certificate plus 8% percent interest per annum. The motion being put, upon call of roll the Councilmen noted as follows: Hirons, yea; Marshall, yea; Miller, Yea; Dowrey, yea; Meders, yea; Murr, yea. All the Councilmen voting yea, the motion was declared carried.

Moved by Councilman Murr, seconded by Councilman Miller that Sterling B. Lacy be given part of the Fire Insurance business done by the City. Motion carried.

The question of raising the fee on all licenses granted by the City was discussed.

Moved by Councilman Murr, seconded by Councilman Miller, that a committee be appointed by the chair to look over the list of licenses fees and to recommend what changes should be made. The motion carried and the Councilmen Murr, and Miller and City Manager were appointed to serve on said committee.

There being no further business to bring before the Council, the meeting was adjourned. The next regular meeting being set for January 11, 1922 at 7:30 O'clock.
