MINUTES February 15, 1922

The City Council of the City of Grand Junction met in regular session at 7:30 o'clock P.M. with President Hirons presiding. The Councilmen present were Hirons, Marshall, Miller, Dowrey, Hampson and Murr. Councilman Meders was absent, having been excused. The City Manager, City Clerk, City Attorney and the City Treasurer were present.

The minutes of the last regular session were read and approved.

A.L. Holcombe of the Currie Canning Factory appeared before the Council asking for an extention of sewer and water lines near their property. It was moved by Councilman Murr, seconded by Councilman Marshall, that the matter be referred to the City Manager. Motion carried.

A representative of Harry Spencer of the St. Charles Rooms asked the Council to grant him a permit to construct an addition to the present building now known as the St. Charles Rooms. The Council informed him that he would be required to abide by the ordinances in the constructing thereof.

The following resolution was read by the Clerk:

RESOLUTION

Whereas, certain work is necessary on the cribbing and on the East river bank above the Main Street Bridge crossing the Colorado River in order to protect the property of the City and property owners along said river bank and said Main Street Bridge from flood waters, and

Whereas, the cost of said work is estimated at fourteen hundred dollars (\$1,400.00), and

Whereas, the County Commissioners of Mesa County have agreed to pay one-half of the cost of said work, providing, that the City of Grand Junction pay the other one-half of said costs.

Now, therefore, be it resolved by the City Council of the City of Grand Junction that the City of Grand Junction will spend not exceeding the sum of seven hundred dollars (\$700.00) in said

improvement, providing that the County of Mesa will expend a like sum of seven hundred dollars (\$700.00) in said improvement. Said sum of seven hundred dollars (\$700.00) to be so expended by the City of Grand Junction to be authorized by an ordinance which shall make the appropriation for the expenditure of said sum of seven hundred dollars (\$700.00).

It was moved by Councilman Murr, seconded by Councilman Hampson, that the resolution as read be passed and adopted. The motion being put, upon call of roll the Council voted as follows: Hirons, yea; Marshall, yea; Miller, yea; Dowrey, yea; Hampson, yea; Murr, yea. All the Councilmen present voting yea, the motion was declared carried.

The proof of publication of the Ordinance entitled, "An ordinance amending Section 1, Article 2 of Ordinance No. 83 passed and adopted June 30, 1899" was read. It was moved by Councilman Marshall, seconded by Councilman Hampson, that the proof of publication be accepted and filed. Motion carried.

Moved by Councilman Murr, seconded by Councilman Marshall, that the ordinance entitled "An ordinance amending Section., Article 2 of Ordinance No. 83, passed and adopted June 30, 1899" be taken up for final passage. Motion carried, and the proposed ordinance was read by the Clerk.

It was then moved by Councilman Miller, seconded by Councilman Murr, that the proposed ordinance entitled "An ordinance amending Section 1, Article 2, of Ordinance 83 passed and adopted June 30 1899" be passed and adopted and numbered No. 306. The motion being put, upon call of roll the Councilmen voted as follows: Hirons, yea; Marshall, yea; Miller, yea; Dowrey, yea; Hampson, nay, Murr, yea. The majority of the Councilmen present voting yea, the motion was declared carried and the proposed ordinance was duly passed and adopted.

The proof of publication of an ordinance entitled "An ordinance concerning salaries of certain city officers and employees" was read.

Moved by Councilman Murr, seconded by Councilman Dowrey, that the proof be accepted as read and filed. Motion carried.

It was then moved by Councilman Dowrey, seconded by Councilman Murr, that the proposed ordinance be taken up for final passage. The motion carried and the proposed ordinance was read by the Clerk.

Moved by Councilman Murr, seconded by Councilman Dowrey, that the proposed ordinance entitled "An ordinance concerning salaries of certain City officers and employees" be passed and adopted and numbered 307. The motion being put, upon call of roll the Councilmen present voted as follows: Hirons, yea; Marshall, yea; Miller, yea; Dowrey, yea; Hampson, yea; Murr, yea. All the Councilmen present voting yea, the motion was declared carried.

The following proposed ordinance was read, entitled, "An ordinance providing for the collection and disposal of garbage and the cleaning of grease traps within the City of Grand Junction by contract and repealing Ordinance No. 187, passed and adopted February 23rd, 1911, entitled 'An ordinance providing for the collection and disposal of garbage and the cleaning of grease traps within the City of Grand Junction, be contract, and fixing the license fee of scavengers', and repealing Ordinance No. 252 passed and adopted August 2nd, 1916."

It was moved by Councilman Murr, seconded by Councilman Dowrey that the proposed ordinance as read be passed for publication. Motion carried.

It was moved by Councilman Murr, seconded by Councilman Hampson, that the motion of Feb. 8th, passing the proposed ordinance for publication amending portions of Ordinance No. 178, passed June 11, 1910, be hereby rescinded as changes in the original draft were necessary. The motion carried.

The proposed ordinance entitled, "An ordinance amending Section 2 of Ordinance No. 178, passed June 30, 1910 and entitled 'An ordinance providing for the creation of local improvement districts, the construction therein of certain local improvements and providing a method of payment therefor' as amended by Section 1 of Ordinance No. 294, passed and adopted October 13th, 1920" was read by the Clerk.

Moved by Councilman Murr, seconded by Councilman Hampson that the proposed ordinance as just read be passed for publication. The motion being put, upon call of roll, the Councilman present voted as follows: Hirons, yea; Marshall, yea; Miller, yea; Dowrey, yea; Hampson, yea; Murr, yea. All the councilmen present voting yea, the motion was declared carried.

Moved by Councilman Hampson, seconded by Councilman Dowrey, that the resolution passed and adopted Feb. 1st concerning depository bonds furnished by the banks to the City be and the same is hereby repealed and that a new resolution be drafted by the City Manager and the City Attorney.

The motion being put, upon call of roll, the Councilmen present voted as follows: Hirons, yea; Marshall, yea; Miller, yea; Dowrey, yea; Hampson, yea; Murr, yea. All the Councilmen present voting yea, the motion was declared carried.

There being no further business to come before the Council the meeting was adjourned until February 21, at 7:30 P.M.
