Grand Junction, Colorado August 9, 1922

The City Council of the City of Grand Junction met in regular adjourned session at 8:00 P.M. with Councilman Murr presiding in the absence of President Pro Tem Hampson. The Councilmen present were Murr, Miller, Marshall and Dowrey. Councilmen Hirons, Hampson and Meders were absent. City Manager Garrett, City Attorney Jordan and City Clerk Peck were present. T.E. Thompson City Engineer was also present.

Henry Tupper representing property owners on East Main Street appeared before the Council in regard to the plan of pavement contemplated on that street. Mr. Tupper presented a petition signed by about 55% of the property holders on said street asking that the pavement be 56' wide from 8th street to 12th. St. with no center parking, the Street Railway to pave on their 9'.

S.G. Mc Mullen representing the Grand River Valley Ry. Co. presented to the Council a petition signed by about 34 property holders on East Main ST. requesting the Council to include a center strip of parking on Main St. from 8th. Street to 12th. Street.

It was moved by Councilman Marshall that both of said petitions be accepted and filed and that the Council take action either for or against. Motion carried.

A.B. Campbell appeared before the Council in regard to the contemplated Sewer District on North Seventh Street. Mr. Campbell objected to the sewer being laid in the street.

It was moved by Councilman Marshall seconded by Councilman Dowrey that the matter of where the sewer should be laid be referred to the City Manager and City Engineer for investigation. Motion carried.

It was then moved by Councilman Marshall, seconded by Councilman Dowrey that as the majority of the property owners, as shown by the petitions filed, wanted a 56' road way on East Main Street from 8th St. to 12 St. that the Council order that said Street be paved 56' wide from 8th. Street to 12th. Street. The motion being put, upon call of roll the Councilmen present voted as follows, Murr, yea; Marshall, yea; Miller, yea; Dowrey, yea. All the Councilmen present voting yea, the motion was declared carried.

The following resolution was introduced and read:

RESOLUTION

WHEREAS the Chamber of Commerce of the City of Grand Junction, Mesa County, Colorado is going to take charge of the Fair to be held at Grand Junction, Colorado on the 5th, 6th, 7th, and 8th of September, 1922, and

WHEREAS the City of Grand Junction and the public in general desire that said Fair shall be a success, and

WHEREAS said Fair is a benefit to the City of Grand Junction and the community in general, and

WHEREAS the City of Grand Junction desires to help the Chamber of Commerce in every way that it can to make said Fair a success, and

WHEREAS the expense in putting on the Fair and making it a success will be great.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

Section 1. That all concessions, during said days of the fair, in the City limits shall be turned over to the Chamber of Commerce, that is to say, all concessions in the streets of the City of Grand Junction, during said days of the fair shall be turned over to the Chamber of Commerce.

Section 2. That the Chamber of Commerce shall have the concessions for stands in Lincoln Park north of the ditch of the Grand Valley Irrigation Company running West through said Park, but not south of said ditch or canal, subject however to the ordinances of the city concerning the use of said park.

Section 3. The Chamber of Commerce shall not erect or operate any stand or permit any concession near or adjacent to the entrance gates to said park, outside of said park.

It was moved by Councilman Miller, seconded by Councilman Dowrey that the resolution as read be passed and adopted. The motion being put, upon call of roll the Councilman present voted as

follows, Murr, yea; Marshall, yea; Miller, yea; Dowrey yea. All the Councilmen present voting yea, the motion was declared carried.

The proof of publication of the proposed ordinance entitled'" An ordinance amending Ordinance No. 307, passed and adopted February 15th, 1922, and entitled "An ordinance concerning salaries of certain City officers and employees" was read by the clerk. It was moved by Council Miller, seconded by Councilman Dowrey that the proof of publication be accepted and filed. Motion carried.

It was then moved by Councilman Miller, seconded by Councilman Dowrey that the proposed ordinance be brought up for final passage. Motion carried.

It was then moved by Councilman Miller, seconded by Councilman Dowrey that the proposed ordinance entitled "AN ORDINANCE AMENDING ORDINANCE NO. 307, PASSED AND ADOPTED FEBRUARY 15th, 1922, AND ENTITLED "AN ORDINANCE CONCERNING SALARIES OF CERTAIN CITY OFFICERS AND EMPLOYEES" be passed No. 322 and adopted. The motion being put, upon call of roll the Councilmen present voted as follows Murr, yea; Marshall, yea; Miller, yea; Dowrey, yea. All the Councilmen present voting yea, the motion was declared carried.

The proposed ordinance entitled "An ordinance providing for an emergency appropriation for the maintenance of the water system" was presented and read. Upon motion of Councilman Murr, seconded by Councilman Miller the proposed ordinance was passed for publication.

There being no further business to come before the meeting the Council adjourned until 8:00 A.M. August 21 1922.
