

Grand Junction, Colorado
December 26, 1922

The City Council of the City of Grand Junction met in special session at 7:30 to sit as a canvassing board to canvass the returns of the special election held on December 22 1922. There were present and answering at roll call: President of the Council: W.G. Hirons Councilmen: Wm. Murr, R.G. Miller, W.R. Dowrey and T.J. Hampson, City Manager George Garrett, City Clerk Fred A Peck. Absent Councilman L.O. Marshall and W.E. Meders.

The clerk of the said city presented an affidavit of publishing, and his certificates of posting notices of the special bond election held in said city on the 22nd day of December A.D. 1922.

Thereupon it was moved by Councilman Dowrey, seconded by Councilman Murr that the affidavits of publishing and the certificates of posting notices presented by the clerk be placed on file. Motion carried.

Thereupon the city council proceeded to canvass the returns of said election, which returns were as follows:

Thereupon the following resolution was introduced, and read.

RESOLUTION

WHEREAS, on the 22nd day of December, A.D. 1922, there was submitted to the qualified taxpaying electors of the city of Grand Junction, the question of issuing bonds of the said city in the sum of seventy-one thousand dollars (\$71,000.00) for the purpose of paying the cost of paving street and alley intersections in said city, and the question of issuing the bonds of said city in the sum of one hundred ninety thousand dollars (\$190,000) for the purpose of maintaining, extending and enlarging the water works system of said city, and the question

of issuing the bonds of the city in the sum of four hundred eighty-one thousand two hundred fifty dollars (\$481,250) for the purpose of paying, redeeming and refunding a like amount of outstanding indebtedness of said city; and

WHEREAS, on the 26th day of December, A.D. 1922, the city council duly canvassed the results of said election which were as follows, to-wit:

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That said bond election was held in strict conformity with the laws of the State of Colorado, and the Charter and Ordinances of said city, and it is hereby declared that more than a majority of the votes cast at said election were for the issuance of street intersection bonds in the sum of seventy-one thousand dollars (\$71,000.00); for the issuance of water bonds of the said city in the sum of one hundred ninety thousand dollars (\$190,000.00); and for the issuance of refunding bonds of the said city in the sum of four hundred eighty-one thousand two hundred fifty dollars (\$481,250.00).

It was moved by Councilman Murr, seconded by Councilman Miller that the resolution as read be passed and adopted, upon which motion the following vote was cast:

Councilman voting Yea: Hiron, Miller, Dowrey, Hampson and Murr.

Councilmen voting Nay: None

The President of the Council thereupon declared the motion carried and the resolution duly adopted.

The City Clerk presented an affidavit of publishing, and his certificate of posting notices of the special election held in

the said city on the 22nd day of December 1922 at which election there was submitted to the qualified voters the following:

"Amendment to Section 96 of Article XII of the Charter of the City of Grand Junction relating to Department of Water and Sewers"

"AN ordinance concerning the vacating of that certain alley running north and south in Block 9 of Richard's D Mobley's First Subdivision to the City of Grand Junction and in Bower's Subdivision of Lot 3 in Block 9 of Richard D Mobley's First Subdivision to the City of Grand Junction"
