# Grand Junction, Colorado December 27, 1922

All the members of the City Council of the City of Grand Junction being duly notified the City Council met in special session at 8:00 o'clock P.M., at which meeting there were present and answering at roll call: Councilmen W.G. Hirons, L.O. Marshall, W.E. Meders, R.G. Miller, W.R. Dowrey, T.J. Hampson and Wm. Murr. City Manager Garrett, City Clerk Peck and City Attorney L.W. Jordan.

The following Statement of Paving District No. 6 was presented and read.

STATEMENT SHOWING THE WHOLE COST OF THE IMPROVEMENTS OF GRAND JUNCTION PAVING DISTRICT NUMBER SIX, INCLUDING SIX PER CENT ADDITIONAL FOR COST OF COLLECTION AND OTHER INCIDENTALS, AND INCLUDING INTEREST TO AND INCLUDING THE 28th DAY OF FEBRUARY, 1923, AND APPORTIONING THE SAME UPON EACH LOT OR TRACT OF LAND TO BE ASSESSED FOR THE SAME. Councilmen voting Nay: None.

The following resolution was then introduced and read.

#### RESOLUTION

WHEREAS, the City Engineer of the City of Grand Junction, Colorado, has reported the completion of Paving District No. 6, and

Whereas, the City Council has caused to be prepared a statement showing the whole cost of the improvements of said Paving Dist. No. 6, including therein six per cent additional for costs of collection and other incidentals, and including interest to and including the 28th day of February, 1923, and apportioning the same upon each lot or tract of land or other real estate, to be assessed for the same.

THEREFORE, BE IT RESOLVED that the paving and all improvements connected therewith in said district be and the same are hereby accepted; that the said statement be and the same hereby is approved and accepted as the statement showing the whole cost of the entire improvements of said Paving District No. 6., including six percent additional for cost of collection and other incidentals, and including interest to and including the 28th day of February, 1923; and including

BE IT FURTHER RESOLVED that the same be apportioned on each lot or tract of land, or other real estate, to be assessed for the same, and that the same be certified by the President of the Council, and filed in the office of the City Clerk; and

BE IT FURTHER RESOLVED that the Clerk shall immediately advertise for three days in the Daily Sentinel, a news paper of general circulation published in said city, notice to the owners of the real estate to be assessed, and to all persons interested generally without nameing such owner or owners; that said improvements have been completed and accepted, specifing the whole cost of the improvements and the share so apportioned to each lot or tract of land; that any complaints or objections that may be made in writing by such owners or persons shall be made to the Council and fuled with the Clerk within thirty days from the first publication of said notice; that the same may be heard and determined by the Council at the first regular meeting after said thirty days and before the passage of the Ordinance assessing the cost of the improvements, all being in pursuance of the terms and provisions of Ordinance No. 178 of said City as amended.

Thereupon it was moved by Councilman Marshall seconded by Councilman Murr that the resolution as read be passed and adopted, upon which motion the following vote was cast;

Councilmen voting Yea: W.G. Hirons, L.O. Marshall, R.G. Miller, W.E. Meders, W.R. Dowrey, T.J. Hampson and Wm. Murr. Councilmen voting Nay: None.

All of the Councilmen voting Yea the motion was declared carried and the Cler instruct to carry out the provisions of the resolution.

It was moved by Councilman Marshall, seconded by Councilman Miller that the city clerk be instructed to issue bonds numbered consecutivily from sixty (60) to sixty-six (66) inclusive in the denomination of five hundred dollars each and deliver said bonds to Bosworth, Chanute and Company of Denver, Colorado, the lawful purchaser thereof. Motion carried.

A proposed emergency ordinance entitled "THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION FOR THE FISCAL YEAR BEGINNING JANUARY 1st. A.D. 1923, and ENDING DECEMBER 31st, A.D. 1923. was introduced and read.

Thereupon it was moved by Councilman Meders, seconded by Councilman Murr that the Appropriation Ordinance as read be passed, and adopted as an emergency ordinance, numbered 329 and published in The Daily Sentinel, upon which motion the following vote was cast:

COUNCILMEN voting YEA: Hirons, Marshall, Miller, Meders, Dowrey, Hampson and Murr.

COUNCILMEN voting NAY: None.

All of the Councilmen voting in favor of the passage of the ordinance, the President declared the motion carried and the ordinance duly passed and adopted.

A proposed emergency ordinance entitled "AN ORDINANCE PROVIDING FOR AN EMERGENCY APPROPRIATION FOR THE MAINTENANCE OF THE POLICE DEPARTMENT, FOR STREET LIGHTING, FOR THE MAINTENANCE OF THE HIGHWAY DEPARTMENT, FOR THE CONTINGENT FUND AND FOR THE MAINTENANCE OF THE MOYER POOL" was introduced and read as an emergency ordinance.

Thereupon it was moved by Councilman Hampson, seconded by Councilman Miller that the emergency odinance as read be passed and adopted as an emergency ordinance, numbered 330, and published in the Daily Sentinel, upon which motion the following vote was cast:

COUNCILMEN voting YEA: Hirons, Marshall, Miller, Meders, Dowrey, Hampson and Murr.

COUNCILMEN voting NAY: None.

All the Councilmen voting in favor of the ordinance the President declared the ordian duly passed and adopted.

A proposed emergency ordinance entitled "AN ORDINANCE LEVYING A SPECIAL ASSESSMENT ON CERTAIN REAL ESTATE IN GRAND JUNCTION, FOR BENEFITS CONFERRED BY THE WATER WORKS OF SAID CITY" was introduced and read.

Thereupon it was moved by Councilman Murr, seconded by Councilman Marshall that the ordinance as read be passed and adopted as an emergency ordinance, numbered 331 and published in the Daily Sentinel, upon which motion the following vote was cast:

COUNCILMEN voting YEA: Hirons, Marshall, Miller, Meders, Dowrey, Hampson and Murr.

COUNCILMEN voting NAY: None.

All of the Councilmen voting in favor of the adoption of the ordinance, the President declared the ordinance duly passed and adopted.

The following resolution was introduced and read:

#### RESOLUTION

Whereas there has been submitted to the electors at the Special Election held December 22 1922 a proposed charter amendment providing for "An amendment to Section 96, of Article XII, of the Charter of the City of Grand Junction, relating to the Department of Water and Sewers". That at said election a majority of the votes cast on the question of the adoption oe rejection of said amendment was in favor of the adoption thereof.

Therefore be it resolved that said amendment is hereby declared carried; that the City Clerk be, and he is hereby authorized and instructed, to cause the same to be published once in the official paper of the City and that he file with the Secretary of the State of Colorado two copies thereof with the vote for and against, officially certified by him.

Councilman Hampson moved the adoption of the resolution, the motion was seconded by Councilman Meders. Upon which motion the following vote was cast:

COUNCILMEN VOTING YEA: Hirons, Marshall, Miller, Meders, Dowrey, Hampson and Murr.

Councilmen voting Nay. None.

The President declared the resolution duly passed and adopted.

The following resolution was introduced and read.

### RESOLUTION

Whereas an ordinance entitled "AN ORDINANCE CONCERNING THE VACATING OF THAT CERTAIN ALLEY RUNNING NORTH AND SOUTH IN BLOCK 9 OF RICHARD D MOBLEY'S FIRST SUBDIVISION TO THE CITY OF GRAND JUNCTION AND IN BOWER'S SUBDIVISION OF LOT 3 IN BLOCK 9 OF RICHARD D MOBLEY'S FIRST SUBDIVISION TO THE CITY OF GRAND JUNCTION" was submitted to the qualified electors at the soecial election held December 22 1922 for their adoption or rejection. That at said election a majority of the voted cast on the said question were in favor of the adoption thereof.

Therefore the same is hereby declared to have been passed and adopted by the qualified electors at asid election and the City Clerk is hereby authorized and instructed to cause the same to be published in one issue of the official newspaper of the City of Grand Junction and that the ordinance be numbered People's Ordinance No. 12.

It was moved by Councilman Meders, seconded by Councilman Murr, that the resolution as read be passed and adopted, upon which motion the following vote was cast:

COUNCILMEN voting YEA: Hirons, Marshall, Miller, Meders, Dowrey, Hampson and Murr.

COUNCILMEN voting NAY: None.

All the Councilmen voting in favor of the resolution, the President declared the same duly passed and adopted.

The City Engineer presented a map in connection with Paving District # 6, showing the assessments on each lot or tract of land. It was moved by Councilman Murr, seconded by Councilman Dowrey that the map be accepted and placed on file. Motion carried.
