

Grand Junction, Colorado

May 3, 1923

The City Council of the City of Grand Junction met in regular adjourned session at 8:00 o'clock P.M. with president Hirons presiding. Those present and answering at roll call were: COUNCILMEN Hirons, Dowrey, Marshall, Hampson and Murr, City Manager Garrett, City Clerk Peck and City Attorney Jordan were present. City Engineer Thompson was also present. Councilmen, Miller, Meders were absent.

It was moved by Councilman Murr, seconded by Councilman Hampson that the intersection at 14th and Main Streets be paved and the cost of the same be taken from the Intersection Fund, upon which motion the following vote was cast: Councilmen voting YEA: Hirons, Marshall, Dowrey, Hampson and Murr. Councilman voting NAY: None. All the Councilmen present voting YEA the motion was declared carried.

It was moved by Councilman Murr, seconded by Councilman Hampson that the City Auditor advertise for bids on the construction of Paving District No. 8, said contract to be let to the lowest and most responsible bidder on approval and sale of the bonds for said District, the bids to be received up to 8:00 o'clock P.M. on the 23rd day of May. Upon which motion the following vote was cast: COUNCILMEN voting YEA: Hirons, Marshall, Dowrey, Hampson and Murr, all the Councilmen present voting YEA the motion was declared carried.

The proof of publication of the proposed ordinance entitled "AN ORDINANCE AMENDING SECTION 7 OF ARTICLE II OF ORDINANCE NO. 16, PASSED AND ADOPTED SEPTEMBER 26, 1891" was read. It was moved by Councilman Dowrey, seconded by Councilman Hampson that the ordinance be laid on the table to be taken up at a future date. Upon which motion the following vote was cast: Councilmen voting YEA: Hirons, Marshall, Dowrey, Hampson and Murr. Councilmen voting NAY: none. All the Councilmen present voting YEA, the motion was declared carried.

Bids for the construction of Sidewalk Districts Nos. 6 & 7 were opened in presence of the Council. It was found that W.O. Allison was the lowest and best bidder, he bidding the following:

It was moved by Councilman Hampson, seconded by Councilman Dowrey that as W.O. Allison was the lowest and best bidder on one course sidewalk construction for Districts Nos. 6 & 7 he be given the contract for construction of the same and that the President of the Council and the City Clerk enter into such a contract with him, upon which motion the following vote was cast: Councilmen voting YEA: Hiron, Marshall, Dowrey, Hampson and Murr. Councilmen voting NAY: None. All the Councilmen voting YEA; the motion was declared carried.

The matter of building storm sewers was again brot before the Council by City Engineer T.E. Thompson.

It was moved by Councilman Murr, seconded by Councilman Dowrey that a resolution be drafted creating a sewer district on Rood Ave as outlined by the plans and specifications of the City Engineer, the same to be presented to the Council at an early date. Motion carried.

It was also moved by Councilman Dowrey, seconded by Councilman Marshall that storm sewers be installed on East Main Street in conformity with the plans and specifications of the City Engineer regarding a complete system of storm sewers over the city, upon which motion the following vote was cast: COUNCILMEN voting YEA: Hiron, Marshall, Dowrey, Hampson and Murr. All the Councilmen present voting YEA: the motion was declared carried.

It was moved by Councilman Murr, seconded by Councilman Hampson that the action of the City Manager in awarding the contract for the construction of a new city garage to V.R. Bush for the sum of \$1410.00 be approved as he was the lowest and best bidder on said work. Upon which motion the following vote was cast: Councilmen voting YEA: Hiron, Marshall, Dowrey, Hampson and Murr. Councilmen voting NAY: None. All the Councilmen voting YEA the motion was declared carried.

Upon motion of Councilman Marshall, seconded by Councilman Dowrey the meeting adjourned.
