

Grand Junction, Colorado

June 25, 1923

The City Council of the City of Grand Junction, Colorado met in pursuance to adjournment at the hour of 7:30 o'clock. Those present and answering at roll call were: Councilmen Hirons, Marshall, Miller, Dowrey, Hampson and Murr, City Manager Garrett, City Clerk Peck and City Attorney Jordan. City Engineer Thompson was also present. Councilman Meders was absent.

It was moved by Councilman Murr, seconded by Councilman Hampson that the Council go into executive session to consider the applicants for the Office of City Treasurer made vacant by the resignation of Mrs. Ruth Newton-Reeds. Motion carried.

After a short executive session the Council was again called to order by the President.

The name of John McKinney was placed before the Council by Councilman Dowrey as nominee for City Treasurer. Councilman Marshall presented the name of Georgia Grady for the same office.

It was moved by Councilman Hampson, seconded by Councilman Dowrey that the nominations be closed. Motion carried.

It was then moved by Councilman Dowrey, seconded by Councilman Murr that John G. Mc Kinney be appointed to the Office of City Treasurer of the City of Grand Junction, upon which motion the following vote was cast: Councilmen voting YEA: Miller, Dowrey, Hampson and Murr, Councilmen voting NAY: Hirons and Marshall. The majority of the Councilmen present voting YEA, the President declared the motion carried, and the appointment of John G. McKinney was confirmed.

The matter of mailing monthly notices to water users was referred to the City Manager.

It was moved by Councilman Murr, seconded by Councilman Marshall that the plans of the City Engineer as outlined in the map presented to the Council in regard to a Combined Storm and Sanitary sewer in the City of Grand Junction be approved and that the City Attorney be instructed to draft the necessary resolutions to create the district to be known as Combined Sewer Dist. No. 2. Upon which motion the following vote was cast. Councilmen voting YEA: Hirons, Marshall, Miller, Dowrey, Hampson and Murr, Councilmen voting NAY: None. All the Councilmen present voting YEA, the motion was declared carried.

Moved by Councilman Miller, seconded by Councilman Murr that the City Clerk be instructed and authorized to call for bids on the construction of Combined Sewer Dist. No. 1, said bids to be

subject to the legality of the bonds for said district and returnable on July 5th at the hour of 8:00 o'clock. Upon which motion the following vote was cast: Councilmen voting YEA: Hirons, Marshall, Miller, Dowrey, Hampson and Murr. Councilmen voting NAY: None. All the Councilmen present voting YEA the motion was declared carried.

It was moved by Councilman Miller, seconded by Councilman Murr that the water pipe between Pitkin and Ute Avenues on South Sixth Street be left as it is at this time as the laying of another main on this street would necessitate the cutting of the concrete pavement on this street. Motion carried.

It was moved by Councilman Murr, seconded by Councilman Miller that the City Attorney be instructed to look up the titles on the 40 acre tract of land lying due East of Lincoln Park. Motion carried.

There being no further business to come before the meeting it was moved by Councilman Hampson, seconded by Councilman Murr that the meeting adjourn until July 5th 1923 at the hour of 8:00 o'clock P.M. as the regular meeting date would be a holiday. Motion carried.
