

July 18 1923

The City Council of the City of Grand Junction, Colo. met in regular session at 8:00 o'clock P.M. with President Hirons presiding. Those present and answering at roll call were Councilmen Hirons, Marshall, Miller, Dowrey, Hampson and Murr, City Manager Garrett, City Clerk Peck. City Attorney Jordan was absent.

The Minutes of the last regular session and of the adjourned session of July 5th were read and approved.

A petition from the Young People's Societys of the city was presented to the Council. Said petition requested that the band concerts be given earlier in the evening so as to not interfere with the meetings of the Young People's Society. Thereupon it was moved by Councilman Hampson, seconded by Councilman Murr that the hour of the band concert on Sunday be from the hour of 5:00 o'clock P.M. to 6:00 o'clock P.M. Motion carried;

A communication was read from Mrs. Elizabeth Cox requesting that the persons living at 519 Rockway be given the use of city water free of charge as they were in destitute circumstances. It was moved by Councilman Marshall, seconded by Councilman Meders that the communication be received and filed. Motion carried.

It was moved by Councilman Murr, seconded by Councilman Marshall that the City Manager be instructed to place the drinking fountain now situated at the corner of Fifth Streets and Rood Ave, in Washington Park. Motion carried.

The surety bond of the Orman Construction Company on Combined Sewer Dist. No. 1 was presented. It was moved by Councilman Dowrey, seconded by Councilman Marshall that the bond be accepted and filed. Motion carried.

The surety bond of the Strange-McGuire Paving Company on Paving Dist. No. 8 was presented. It was moved by Councilman Marshall, seconded by Councilman Meders that the bond be accepted and filed. Motion carried.

It was moved by Councilman Dowrey, seconded by Councilman Murr that the City Manager and City Engineer be instructed to obtain estimates on the repairing of the pavement on south Second Street and Colorado Ave., they to also make estimates on the cost of repaving South Second Street. Motion carried.

It was moved by Councilman Murr, seconded by Councilman Miller that J.E. Ragan be employed to audit the books and accounts of the city for the year 1923 for the amount of \$375.00. Upon which motion the following vote was cast: Councilman voting YEA: Hirons, Marshall, Miller, Dowrey, Hampson and Murr. Councilmen

voting Nay: None. All the Councilmen voting Yea, the President declared the motion carried.

It was moved by Councilman Miller, seconded by Councilman Murr that the street intersection at 12th Streets and Gunnison Ave. be paved and the cost of the same to be paid out of the Intersection Fund. Upon which motion the following vote was cast. Councilmen voting YEA: Hirons, Marshall, Miller, Dowrey, Hampson and Murr. Councilmen voting NAY: None. All the Councilmen voting YEA, the President declared the motion carried.

The emergency ordinance entitled: AN EMERGENCY ORDINANCE REGULATING STREET TRAFFIC OF THE CITY OF GRAND JUNCTION, AMENDING ORDINANCE NO. 309, PASSED AND ADOPTED FEBRUARY 21, 1922 ENTITLED 'AN EMERGENCY ORDINANCE REGULATING STREET TRAFFIC OF THE CITY OF GRAND JUNCTION? WHEREAS FOR THE PRESERVATION OF THE PUBLIC SAFETY IT HAS BECOME NECESSARY TO MORE FULLY REGULATE STREET TRAFFIC IN THE CITY OF GRAND JUNCTION" was presented and read as an emergency ordinance.

It was moved by Councilman Murr, seconded by Councilman Marshall that the ordinance be brot up for final passage. Motion carried.

The proposed ordinance was read by the clerk.

It was then moved by Councilman Marshall, seconded by Councilman Murr that the ordinance as read and entitled "AN EMERGENCY ORDINANCE REGULATING STREET TRAFFIC OF THE CITY OF GRAND JUNCTION, AMENDING ORDINANCE NO. 309, PASSED AND ADOPTED FEBRUARY 21, 1922 ENTITLED 'AN EMERGENCY ORDINANCE REGULATING STREET TRAFFIC OF THE CITY OF GRAND JUNCTION, WHEREAS FOR THE PRESERVATION OF THE PUBLIC SAFETY IT HAS BECOME NECESSARY TO MORE FULLY REGULATE STREET TRAFFIC IN THE CITY OF GRAND JUNCTION" be passed and adopted as an emergency ordinance, numbered 337 and published in the Daily Sentinel, upon which motion the following vote was cast: Councilmen voting YEA: Hirons, Marshall, Miller, Meders, Hampson and Murr. All the Councilmen voting Yea, the president declared the motion carried.

It was moved by Councilmen Murr, seconded by Councilman Miller that the City Manager move the Exhibition Building situated at Lincoln Park from it's present site, upon which motion the following vote was cast, Councilmen voting YEA: Hirons, Marshall, Miller, Meders, Hampson and Murr. All the Councilmen voting YEA, the President declared the motion carried.

Upon motion of Councilman Murr, seconded by Councilman Marshall the meeting adjourned.
