

Grand Junction, Colorado

October 17, 1923

The City Council of the City of Grand Junction met in regular adjourned session at 8:00 o'clock P.M. with the following present: Councilmen Murr, Marshall, Meders, Miller and Hampson, City Manager Garrett, City Auditor Peck, City Attorney Jordan and City Engineer Thompson. Councilman Hirons and Dowrey were absent.

On motion of Councilman Hampson seconded by Councilman Miller and unanimously carried Councilman Murr was elected to preside due to the absence of President Hirons.

Bids on the construction of paving district No. 10 were opened and read. The City Engineer was instructed to tabulate the bids and report his findings to the Council.

J.U. Harris was present protesting against the laying of a 4" water main on North Seventh Street. Mr. Harris contended that a 4" main was not large enough to supply sufficient water to the consumers along this street. This matter was taken under consideration.

The following estimate was presented and read:

It was moved by Councilman Hampson, seconded by Councilman Meders that the estimate as read be accepted and allowed, upon which motion the following vote was cast: Councilman voting Yea, Murr, Marshall, Miller, Meders and Hampson. All the Councilmen present voting Yea the motion was declared carried.

The question of letting the contract for the bonds of Pav. Dist. # 10 was discussed. It was discovered that the resolution creating the district was not completed and thereupon it was moved by Councilman Hampson seconded by Councilman Meders that the contract for the bonds on Pav. # 10 be held up for further consideration or until the necessary resolution could be prepared. Motion carried.

It was moved by Councilman Marshall, seconded by Councilman Miller that the prayer of J.U. Harris et al regarding the installation of a 6" water main on North Seventh Street be not granted. Motion carried.

It was moved by Councilman Meders, seconded by Councilman Miller that the action taken on Oct. 15 1923 in regard to the calling for bids on the construction of Comb. Sewer Dist. # 2 be recinded, upon which motion the following vote was cast: Councilmen voting Yea, Murr, Marshall, Meders, Miller and Hampson. All the Councilmen present voting Yea, the President declared the motion carried.

It was moved by Councilman Meders, seconded by Councilman Marshall that the Grand River Valley Ry. Co. be permitted for the present to place gravel in the perking strip on Gunnison Ave., between 7th and 12th Sts. with the understanding that the gravel would not be considered as paving. Upon which motion the following vote was cast: Councilmen voting Yea, Murr, Marshall, Meders, Miller, Hampson. All the Councilmen present voting Yea, the motion was declared carried.

It was moved by Councilman Hampson, seconded by Councilman Meders that the City Manager and City Engineer investigate the cost of placing the pipe deeper on the island at the river crossing of the water works improvements. They to report their findings to the council. Motion carried.

The communication from Rev. Brown in regard to a Community Chest was filed for future reference on the motion of Councilman Meders seconded by Councilman Miller, and unanimously carried.

The bids for the bonds on Combined Sewer Dist. #2 were taken up.

It was moved by Councilman Meders, seconded by Councilman Miller that the bid of Bosworth, Chanute and Company of \$991.11 per \$1,000.00 for bonds of Combined Sewer District # 2 be accepted and that the President of the Council and City Clerk be authorized to sign the contract for the same. Upon this motion the following vote was cast: Councilmen voting YEA, Murr, Marshall, Meders, Miller and Hampson. All the Councilmen present voting Yea, the President declared the motion carried.

It was moved by Councilman Marshall, seconded by Councilman Meders that the action of the Council on Sept. 19 1923 in regard to the installation of 8" water pipe under the right of way of the D. & R.G. Ry. Co on west Main St. be recinded as the Paving of this street could not be accomplished this fall. Motion carried.

Upon motion of Councilman Marshall, seconded by Councilman Meders that the meeting adjourn until 5:30, P.M. Oct. 18 1923. Motion carried.
