Grand Junction, Colorado

November 21, 1923

The City Council of the City of Grand Junction met in regular session at 8:00 o'clock P.M. with President Hirons presiding. Those present and answering at roll call were Councilmen Hirons, Meders, Miller, Hampson and Murr, Act. City Manager Thompson, City Attorney Jordan and City Clerk Peck. Councilmen Marshall and Dowrey were absent.

The minutes of the last regular meeting and of the special meeting of November 19th read and approved.

A petition for a sidewalk district in the NE part of the city signed by Dr. J.E. Bell et al was presented and read.

It was moved by Councilman Meders, seconded by Councilman Murr that the petition be accepted and filed. Motion carried.

A petition for the paving of the blocks between Teller and North Ave. on North 7th St was presented. It was moved by Councilman Murr, seconded by Councilman Meders that the petition be accepted and filed. Motion carried.

It was moved by Councilman Murr, seconded by Councilman Meders that the City Clerk advertise for bids on the construction of Paving Dist. # 11 subject to the sale and approval of the bonds, bids on the same to be received up to 8:00 o'clock P.M. on December 5 1923. Upon this motion the following vote was cast: Councilmen voting Yea, Hirons, Miller, Meders, Hampson and Murr. All the Councilmen present voting yea, the president declared the motion carried.

A proposed ordinance entitled "AN ORDINANCE CONCERNING SALARY AND COMPENSATION OF THE CITY ATTORNEY" was introduced and read. It was moved by Councilman Miller, seconded by Councilman Meders that the ordinance be passed for publication. Upon this motion the following vote was cast: Councilmen voting yea, Hirons, Meders, Meders, Hampson and Murr. All the Councilmen present voting yea, the president declared the motion carried.

The proof of publication of the proposed ordinance entitled "AN ORDINANCE CONCERNING THE SALARY OF THE CITY MANAGER" was read. It was moved by Councilman Miller, seconded by Councilman Hampson that the proof of publication be accepted and filed. Motion carried.

The proposed ordinance was then read by the Clerk.

It was then moved by Councilman Miller, seconded by Councilman Hampson that the proposed ordinance as read be passed and

adopted, numbered 340 and published. Upon which motion the following vote was cast: Councilmen voting yea, Hirons, Miller, Meders and Hampson. Councilmen voting Nay, Murr. The majority of the Councilmen voting yea, the president declared the motion carried, and the ordinance was duly declared adopted.

The following estimate was presented and read.

Upon which motion the following vote was cast: Councilmen voting yea, Hirons, Miller, Meders, Hampson and Murr. All the Councilmen present voting yea, the President declared the motion carried.

A proposed ordinance concerning the inspection of meat was read. After much discussion by farmers and others the President suggested that a committee composed of the framers of the ordinance and those opposed to it get together and discuss the points in question and present the revised ordinance to the Council at the next meeting.

On motion of Councilman Hampson, seconded by Councilman Murr the meeting adjourned until 8:00 o'clock P.M. November 28 1923.
